The Council is reviewing its planning policies. To stimulate discussion about how our District should develop over the next 20 years, the Council has published a document that identifies the major issues it thinks we are facing.

Take a look at the 'Core Strategy Launch Document' and let us know what you think. Details of how to do this and where you can find the document are included in this leaflet.

The Core Strategy

Work to put together a new generation of planning policies which will set out the broad locations for new housing, jobs and community facilities is being launched by the Council. Some of these new policies will be set out in a document called the Core Strategy.

The Core Strategy will set out the long term planning framework for the District looking ahead to 2026.

It will take on board the findings of studies, other Council strategies and consultations, including the Sustainable Community Strategy and the 'Future for Bath and North East Somerset Visions'.









What is the major spatial issue facing Bath and North East Somerset?

The District will need to deliver unprecedented levels of growth in housing and other areas over the next 20 years while also addressing the challenge of climate change. We need to find land for up to 16,000 new homes.

This is not the only issue facing the District. We recognise that there are different issues facing Bath, Keynsham, Midsomer Norton and Radstock, and the rural areas.

We want you to tell us:

- Has the Launch Document correctly identified the main issues for each area?
- What do you think are the best options for tackling the issues?



What about Bath?

We think achieving the delivery of economic and housing growth whilst protecting and enhancing Bath's environment is the key strategic issue for the City. Optimum use of opportunities within the City will help to minimise the amount of development on greenfield land outside the existing built up area. The Regional Spatial Strategy proposes that housing that cannot be accommodated within Bath should be met through an 'urban extension' to the City. The 'most sustainable' area is considered to be to the south and west of Bath. The 'Future for Bath and North East Somerset Visions' suggest various options for addressing some of the economic issues facing Bath.

We suggest other major issues for Bath include:

- protecting and enhancing Bath's unique character
- accommodating economic growth and sufficient affordable housing to help meet future need
- meeting shopping needs
- the City as an important visitor destination
- impact of the expansion of the Universities and student population




Illustration of the Regional Spatial Strategy 'Area of Search' for the Bath Urban Extension
