The Council is reviewing its planning policies. To stimulate discussion about how our District should develop over the next 20 years, the Council has published a document that identifies the major issues it thinks we are facing.

The Core Strategy

Work to put together a new generation of planning policies which will set out the broad locations for new housing, jobs and community facilities is being launched by the Council. Some of these new policies will be set out in a document called the Core Strategy.

The Core Strategy will set out the long term planning framework for the District looking ahead to 2026.

It will take on board the findings of studies, other Council strategies and consultations, including the Sustainable Community Strategy and the 'Future for Bath and North East Somerset Visions'.









What is the major spatial issue facing Bath and North East Somerset?

The District will need to deliver unprecedented levels of growth in housing and other areas over the next 20 years while also addressing the challenge of climate change. We need to find land for up to 16,000 new homes.

This is not the only issue facing the District. We recognise that there are different issues facing Bath, Keynsham, Midsomer Norton and Radstock, and the rural areas.

We want you to tell us:

- Has the Launch Document correctly identified the main issues for each area?
- What do you think are the best options for tackling the issues?



What about Midsomer Norton, Radstock and environs?

We think the main issue for this area is the vulnerable local economy and the need to maintain the employment level and to attract a range of new and different types of jobs. The local economy in this area is largely dependant on a few big employers and is vulnerable to restructuring.

We suggest other major issues for Midsomer Norton, Radstock and environs include:

- The role and function of the settlements
- New houses how many and where?
- Transport infrastructure, poor public transport and out-commuting
- Bringing forward improvements to local facilities: shopping, social and health facilities and recreation e.g. Midsomer Norton Town Park Proposal
