This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, that rights of way which are not shown in the map and statement subsist or are reasonably alleged to subsist over land in the area to which the map relates, being rights of way such that the land over which the rights subsist are public paths.


The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 11<sup>th</sup> July 2017.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council City of Bath Definitive Map and Statement Modification Order (No. 15 – Westmoreland) 2017.



###### **BC24/35**

A public footpath commencing from a junction with Albany Road at grid reference ST 7290 6458 (Point A on the map numbered Part 3, attached to this Order) and proceeding in a generally southerly direction for approximately 34 metres to a junction with public footpath BC24/31 at grid reference ST 7291 6455 (Point B on the Order Map). The footpath continues for approximately 17 metres to staggered barriers at grid reference ST 7291 6453 (Point C on the Order Map). The footpath continues for approximately 10 metres to Loxton Drive at grid reference ST 7291 6453 (Point D on the Order Map).

###### **BC24/36**

A public footpath commencing from a junction with Shophouse Road at grid reference ST 7284 6448 (Point A on the map numbered Part 4, attached to this Order) and proceeding in a generally easterly direction for approximately 104 metres to grid reference ST 7294 6447 (Point B on the Order Map). The footpath turns in a generally southerly direction and continues for approximately 3 metres to steps at grid reference ST 7294 6447 (Point C on the Order Map). The footpath continues up three flights of steps for approximately 15 metres to Priddy Close at grid reference ST 7294 6446 (Point D on the Order Map).

###### **BC33/4**

A public footpath commencing from a junction with Lymore Avenue at grid reference ST 7345 6395 (Point A on the map numbered Part 5, attached to this Order) and proceeding in a generally easterly direction for approximately 43 metres through grid reference ST 7346 6395 (Point B on the Order Map) to grid reference ST 7349 6395 (Point C on the Order Map). The footpath turns in a generally south-easterly direction for approximately 69 metres to grid reference ST 7354 6390 (Point D on the Order Map) and continues for approximately 95 metres to grid reference ST 7362 6386 (Point E on the Order Map). The footpath turns in a generally north-easterly direction for approximately

86 metres through grid references ST 7362 6386 and ST 7368 6390 (Points F and G on the Order Map) to grid reference ST 7368 6391 (Point H on the Order Map). The footpath turns in a generally south-easterly direction for approximately 6 metres to grid reference ST 7369 6390 (Point I on the Order Map). The footpath turns in a generally north-easterly direction for approximately 25 metres to grid reference ST 7371 6392 (Point J on the Order Map). The footpath turns in a generally south-easterly for approximately 52 metres to Monksdale Road at grid reference ST 7374 6389 (Point K on the Order Map).

#### **BC33/5**

A public footpath commencing from a junction with Ivy Avenue at grid reference ST 7328 6385 (Point A on the map numbered Part 6, attached to this Order) and proceeding in a generally south-easterly direction for approximately 33 metres to a bollard at grid reference ST 7331 6383 (Point B on the Order Map). The footpath continues for approximately 38 metres to Coronation Avenue at grid reference ST 7334 6381 (Point C on the Order Map).

#### **BC33/6**

A public footpath commencing from a junction with Coronation Avenue at grid reference ST 7334 6380 (Point A on the map numbered Part 7, attached to this Order) and proceeding in a generally south-easterly direction for approximately 49 metres to a junction with public footpath BC33/9 at grid reference ST 7339 6377 (Point B on the Order Map). The footpath continues for approximately 2 metres to a pedestrian gate at grid reference ST 7339 6377 (Point C at grid reference). The footpath continues for approximately 4 metres to grid reference ST 7339 6377 (Point D on the Order Map). The footpath turns in a generally north-north-easterly direction for approximately 33 metres to grid reference ST 7341 6380 (Point E on the Order Map) and turns in a generally south-easterly direction for approximately 154 metres to a pedestrian gate on Monksdale Road at grid reference ST 7354 6373 (Point F on the Order Map).

A public footpath commencing from a junction with Hillcrest Drive at grid reference ST 7310 6367 (Point A on the map numbered Part 8, attached to this Order) and proceeding in a generally east-south-easterly direction for approximately 15 metres to steps at grid reference ST 7311 6366 (Point B on the Order Map).
