This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i), namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that rights of way which are not shown in the map and statement subsist or are reasonably alleged to subsist over land in the area to which the map relates, being rights of way such that the land over which the rights subsist are public paths and an event specified in section 53(3)(c)(iii) namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that any other particulars contained in the map and statement require modification.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this Order the relevant date is 12<sup>th</sup> January 2023.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the maps attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council City of Bath Definitive Map and Statement Modification Order (No. 20 – Moorlands, Oldfield Park and Westmoreland) 2023.

The footpath continues for approximately 20 metres to a junction with public footpath BC33/14 at Grid Reference ST 7364 6361 (Point D on the Order Map). The footpath continues for approximately 29 metres to a junction with public footpath BC33/15 at Grid Reference ST 7365 6359 (Point E on the Order Map). The footpath continues for approximately 1 metre to Grid Reference ST 7365 6359 (Point F on the Order Map) and turning in a generally southerly direction. The footpath continues for approximately 65 metres to Moorfields Road at Grid Reference ST 7365 6352 (Point G on the Order Map).

The footpath proceeds for approximately 21 metres to Grid Reference ST 7358 6360 (Point C on the Order Map), turning in a generally north-easterly direction. on the Order Map) and continues for approximately 7 metres to public footpath BC33/12 at Grid Reference ST 7363 6363 (Point E on the Order Map).

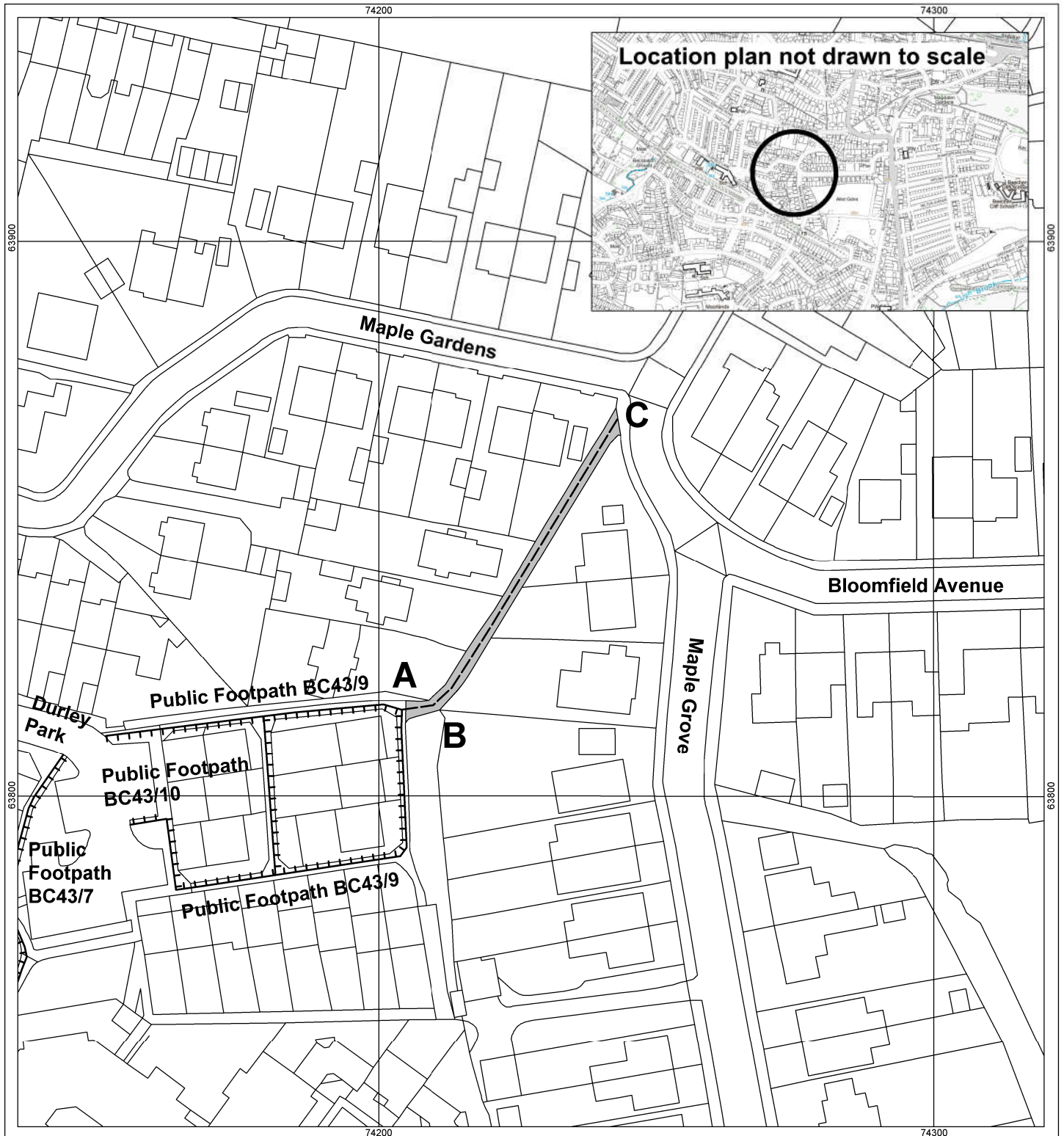
