Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No. 5 – Newbridge) 2006

This Order is made by Bath and North East Somerset Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ('the Act') because it appears to that authority that the City of Bath Definitive Map and Statement require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, that a right of way which is not shown on the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way to which this Part applies.

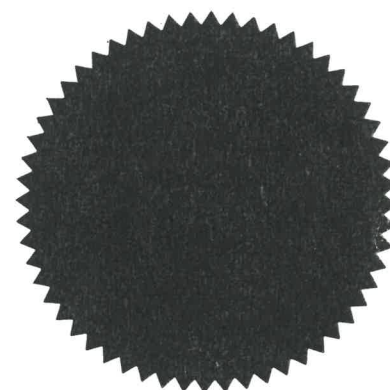
The authority has consulted with every local authority whose area includes the land to which the order relates. The Bath and North East Somerset Council hereby order that:

1. For the purposes of this order the relevant date is 10<sup>th</sup> October 2006.
2. The City of Bath Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the Bath and North East Somerset Council (City of Bath Definitive Map and Statement Modification Order) (No. 5 – Newbridge) 2006.

## SCHEDULE

#### Modification of Definitive Map

##### Description of paths or ways to be added

###### AQ15a

A footpath in Bath and North East Somerset running from point A on Penn Lea Road at Grid Reference ST 7251 6586 and continuing in an easterly direction for a distance of approximately 30m to point B at Grid Reference ST 7254 6587 where the direction changes to east-south-easterly. It continues for a distance of approximately 45m to point C at Grid Reference ST 7257 6583 where the direction changes to easterly and continues for a further 36m to point D at Grid Reference ST 7260 6583 where it finishes on Manor Park at Grid Reference ST 7260 6583 and shown by a broken black line with short intervals marked A-B-C-D on the map numbered AQ15a annexed to this order, the number of this footpath to be known as BC25/5.

###### AQ15b

A footpath in Bath and North East Somerset running from point A on Manor Park at Grid Reference ST 7261 6581 and continuing in an easterly direction for a distance of approximately 24m to point B at Grid Reference ST 7264 6581 where it finishes on AQ16a and shown by a broken black line with short intervals marked A-B on the map numbered AQ15b annexed to this order, the number of this footpath to be known as BC25/6.

###### AQ16a

A footpath in Bath and North East Somerset running from point A on Newbridge Hill at Grid Reference ST 7263 6550 and continuing in a northerly direction for a distance of approximately 108m to a set of staggered barriers at point B at Grid Reference ST 7263 6560. The footpath continues for a distance of approximately 205m to a set of staggered barriers at point C at Grid Reference ST 7264 6581. After a distance of approximately 10m, another set of staggered barriers is reached at point D at Grid Reference ST 7264 6582. The footpath continues for a distance of approximately 196m to a set of staggered barriers at point E at Grid Reference ST 7268 6601. After a further distance of approximately 40m, the footpath finishes at point F at Grid Reference ST 7268 6605 on Chandler Close and shown by a broken black line with short intervals marked A-B-C-D-E-F on the map numbered AQ16a annexed to this order, the number of this footpath to be known as BC25/9.

###### AQ17

A footpath in Bath and North East Somerset running from point A on Charmouth Road at Grid Reference ST 7262 6528 and continuing in an east-south-easterly direction for a distance of approximately 63m to point B at Grid Reference ST 7268 6526 where the direction changes to northerly. The footpath continues for a distance of approximately 210m to point C at Grid Reference ST 7271 6546 where it finishes on Newbridge Hill and shown by a broken black line with short intervals marked A-B-C on the map numbered AQ17 annexed to this order, the number of this footpath to be known as BC25/10.

###### AQ31

A footpath in Bath and North East Somerset running from point A on Locksbrook Road at Grid Reference ST 7305 6493 and continuing in a southerly direction for a distance of approximately 75m to staggered barriers at point D at Grid Reference ST 7305 6485. It continues across the footbridge for a distance of approximately 91m to another set of staggered barriers at point E at Grid Reference ST 7307 6477. The footpath continues for a distance of approximately 4m to point F at Grid Reference ST 7308 6476 where it finishes on Fieldings Road and shown by a broken black line with short

intervals marked A-B-C-D-E-F on the map numbered AQ31 annexed to this order, the number of this footpath to be known as BC34/3.

#### AQ334a

A footpath in Bath and North East Somerset running from point A at steps on Newbridge Road at Grid Reference ST 7210 6558 and continuing along a path in a south-westerly direction for a distance of approximately 3m to point B at Grid Reference ST 7210 6557 where the direction changes to south-easterly. The footpath continues for a distance of approximately 50m to point B at Grid Reference ST 7214 6554 where it finishes on AQ334c and shown by a broken black line with short intervals marked A-B-C on the map numbered AQ334 & CQ97 annexed to this order, the number of this footpath to be known as BC25/7.

#### AQ334c

A footpath in Bath and North East Somerset running from point D on CQ97 at Grid Reference ST 7212 6551 and continuing in a north-easterly direction for a distance of approximately 43m to point E at Grid Reference ST 7214 6555 where the direction changes to north-westerly. The footpath continues for a distance of approximately 9m to steps at point F at Grid Reference ST 7213 6555 where the direction changes to south-westerly. The footpath continues down the steps for a distance of approximately 2m and continues for a distance of approximately 2m to point G at Grid Reference ST 7213 6555 where it finishes on AQ334a and shown by a broken black line with short intervals marked D-E-F-G on the map numbered AQ334 & CQ97 annexed to this order, the number of this footpath to be known as BC25/8(Part).

#### AQ334f

A footpath in Bath and North East Somerset running from point H on Brassmill Lane at Grid Reference ST 7206 6545 and continuing in a north-easterly direction for a distance of approximately 42m to point I at Grid Reference ST 7209 6548 where it finishes on CQ97 and shown by a broken black line with short intervals marked H-I on the map numbered AQ334 & CQ97 annexed to this order, the number of this footpath to be known as BC25/8(Part).

#### CQ97

A footpath in Bath and North East Somerset running from point I on AQ334f at Grid Reference ST 7209 6548 and continuing in a north-easterly direction for a distance of approximately 38m to point D at Grid Reference ST 7212 6551 where it finishes on AQ334c and shown by a broken black line with short intervals marked I-D on the map numbered AQ334 & CQ97 annexed to this order, the number of this footpath to be known as BC25/8(Part).

#### AQ336

A footpath in Bath and North East Somerset running from point A on CQ91 at Grid Reference ST 7235 6514 and continuing in a south-easterly direction for a distance of approximately 34m to point B at Grid Reference ST 7237 6511 where it finishes on Avon Park and shown by a broken black line with short intervals marked A-B on the map numbered AQ336 annexed to this order, the number of this footpath to be known as BC25/14.

#### AQ337

A footpath in Bath and North East Somerset running from point A on Avon Park at Grid Reference ST 7241 6506 and continuing in a south-easterly direction for a distance of approximately 35m to point B at Grid Reference ST 7244 6503 where it finishes on CQ90 and shown by a broken black line with short intervals marked A-B on the map numbered AQ337 annexed to this order, the number of this footpath to be known as BC25/17.



AQ338

A footpath in Bath and North East Somerset running from point A on Brassmill Lane at Grid Reference ST 7243 6497 and continuing in a northerly direction for a distance of approximately 31m to point B at Grid Reference ST 7244 6500 where it finishes on CQ90 and shown by a broken black line with short intervals marked A-B on the map numbered AQ338 annexed to this order, the number of this footpath to be known as BC25/18.

AQ339

A footpath in Bath and North East Somerset running from point A on Brassmill Lane at Grid Reference ST 7263 6489 and continuing in a northerly direction for a distance of approximately 130m to point B at Grid Reference ST 7262 6502 where it finishes on Osborne Road and shown by a broken black line with short intervals marked A-B on the map numbered AQ339 annexed to this order, the number of this footpath to be known as BC24/2.

BQ10

A footpath in Bath and North East Somerset running from point A on Brassmill Lane at Grid Reference ST 7225 6520 and continuing in a north-easterly direction for a distance of approximately 17m to point B at Grid Reference ST 7227 6521 where the direction changes to south-easterly. The footpath continues for a distance of approximately 110m to point C at Grid Reference ST 7236 6516 where the direction changes to north-easterly. The footpath continues for a distance of approximately 10m to point D at Grid Reference ST 7237 6516 where the direction changes to south-easterly. After a distance of approximately 120m, the footpath ascends wooden steps at point E at Grid Reference ST 7248 6512. The direction changes to north-north-easterly and continues for a distance of approximately 82m to point F at Grid Reference ST 7251 6520 where it finishes on stone steps descending to Newbridge Road and shown by a broken black line with short intervals marked A-B-C-D-E-F on the map numbered BQ10 annexed to this order, the number of this footpath to be known as BC25/11.

CQ90

A footpath in Bath and North East Somerset running from point A on BQ10 at Grid Reference ST 7236 6516 and continuing in a south-easterly direction for a distance of approximately 141m to point B at Grid Reference ST 7246 6506 where the direction changes to south-south-westerly. The footpath continues for a distance of approximately 18m to point C at Grid Reference ST 7245 6504. The direction of the footpath changes to south-westerly and continues for a distance of approximately 40m to point D at Grid Reference ST 7242 6501 where the direction changes to east-south-easterly. The footpath continues for a distance of approximately 24m to point F at Grid Reference ST 7244 6500 where it finishes on AQ338 and shown by a broken black line with short intervals marked A-B-C-D-E-F on the map numbered CQ90 annexed to this order, the number of this footpath to be known as BC25/12.

CQ91

A footpath in Bath and North East Somerset running from point A on CQ90 at Grid Reference ST 7236 6516 and continuing in a south-westerly direction for a distance of approximately 51m to point B at Grid Reference ST 7232 6512 where the direction changes to south-easterly. The footpath continues for a distance of approximately 66m to point C at Grid Reference ST 7236 6507 where it finishes on Avon Park and shown by a broken black line with short intervals marked A-B-C on the map numbered CQ91 annexed to this order, the number of this footpath to be known as BC25/13.

CQ92

A footpath in Bath and North East Somerset running from point A on Avon Park at Grid Reference ST 7237 6506 and continuing in a south-easterly direction for a distance of approximately 66m to point B at Grid Reference ST 7241 6501 where the direction changes to north-easterly. The footpath continues for a distance of approximately 11m to point C at Grid Reference ST 7242 6501 where it finishes on

CQ90 and shown by a broken black line with short intervals marked A-B-C on the map numbered CQ92 annexed to this order, the number of this footpath to be known as BC25/16.

CQ93

A footpath in Bath and North East Somerset running from point A on Avon Park at Grid Reference ST 7240 6509 and continuing in a north-easterly direction for a distance of approximately 32m to point B at Grid Reference ST 7242 6511 where it finishes on CQ90 and shown by a broken black line with short intervals marked A-B on the map numbered CQ93 annexed to this order, the number of this footpath to be known as BC25/15.

CQ94

A footpath in Bath and North East Somerset running from point A on Brassmill Lane at Grid Reference ST 7233 6506 and continuing in a south-easterly direction for a distance of approximately 22m to point B at Grid Reference ST 7235 6506 where it finishes on Avon Park and shown by a broken black line with short intervals marked A-B on the map numbered CQ94 annexed to this order, the number of this footpath to be known as BC25/19.

CQ95

A footpath in Bath and North East Somerset running from point A on Brassmill Lane at Grid Reference ST 7235 6503 and continuing in a northerly direction for a distance of approximately 24m to point B at Grid Reference ST 7236 6505 where it finishes on Avon Park and shown by a broken black line with short intervals marked A-B on the map numbered CQ95 annexed to this order, the number of this footpath to be known as BC25/20.

CQ99

A footpath in Bath and North East Somerset running from point A on Lower Bristol Road at Grid Reference ST 7253 6478 and continuing in a north-north-easterly direction for a distance of approximately 64m to point B at Grid Reference ST 7256 6483 where the direction changes to west-north-westerly. The footpath continues for a distance of approximately 6m to point C at Grid Reference ST 7255 6483 where the direction changes to north-north-easterly. The footpath continues for a distance of approximately 11m to a set of staggered barriers at point D at Grid Reference ST 7255 6484 and then reaches another set of staggered barriers after a distance of approximately 5m at point E at Grid Reference ST 7256 6485. The footpath continues for a distance of approximately 12m to point F at Grid Reference ST 7256 6486 where the direction changes to north-easterly. The footpath continues for a distance of approximately 25m to point G at Grid Reference ST 7258 6487 where the direction changes to easterly. The footpath continues for a distance of approximately 101m to point H at Grid Reference ST 7268 6485 where the direction changes to north-north-easterly and continues for a distance of approximately 45m to point I at Grid Reference ST 7268 6489 where it finishes on Locksbrook Road and shown by a broken black line with short intervals marked A-B-C-D-E-F-G-H-I on the map numbered CQ99 annexed to this order, the number of this footpath to be known as BC24/1.

CQ101

A footpath in Bath and North East Somerset running from point A on Kaynton Mead at Grid Reference ST 7285 6501 and continuing in an easterly direction for a distance of approximately 191m to staggered barriers at point B at Grid Reference ST 7304 6501 where it finishes on Station Road and shown by a broken black line with short intervals marked A-B on the map numbered CQ101 annexed to this order, the number of this footpath to be known as BC25/21.
