BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS CL1/29 AND CL1/30, CAMELEY ROAD, CAMELEY) PUBLIC PATH DIVERSION ORDER 2020

This order is made by Bath and North East Somerset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpaths described in paragraph 1 of this order and the public it is expedient that the line of the paths should be diverted.

Susan Pole of North Barn, Cameley, Temple Cloud BS39 5AH has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER:

1. The public rights of way over the land situate at Cameley Road, Cameley and shown by bold continuous lines on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up from the date that the authority certifies that work has been carried out to bring the site of the new paths described in Article 3 into a fit condition for use by the public.
2. Notwithstanding this order Bristol Water and Cadent Gas shall have the following rights over the land referred to in paragraph 1 namely: where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to Bristol Water or Cadent Gas for the purpose of carrying out their undertaking, Bristol Water and Cadent Gas shall continue to have the same rights in respect of the apparatus as they then had.
3. There shall on the date that the authority certifies that the works to bring the site of the paths described in Part 2 of the Schedule into a fit condition for use by the public have been completed to the reasonable satisfaction of the authority, be public footpaths over the land situate at Cameley Road, Cameley described in Part 2 of the Schedule and shown by bold broken lines on the map contained in this order.
4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The full width of the section of Public Footpath CL1/29 commencing from grid reference ST 6073 5762 (point A on the Order Map) and proceeding in a generally east north-easterly direction for approximately 222 metres to grid reference ST 6095 5067 (point B on the Order Map) and continuing in a generally east north-easterly direction for approximately 67 metres to grid reference ST 6100 5771 (point C on the Order Map).

The full width of the section of Public Footpath CL1/30 commencing from grid reference ST 6114 5753 (point E on the Order Map) and proceeding in a generally northerly direction for approximately 141 metres to grid reference ST 6113 5767 (point F on the Order Map) and continuing in a generally north north-easterly direction for approximately 96 metres to grid reference ST 6116 5776 (point G on the Order Map).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A public footpath commencing from grid reference ST 6073 5762 (point A on the Order Map) and proceeding in a generally north-easterly direction for approximately 239 metres to grid reference ST 6095 5770 (point D on the Order Map) and continuing in a generally east north-easterly direction for approximately 51 metres to grid reference ST 6100 5771 (point C on the Order Map).

Width: 2 metres from grid reference ST 6073 5762 (point A) to grid reference ST 6100 5771 (point C).

A public footpath commencing from grid reference ST 6114 5753 (point H on the Order Map) and proceeding in a generally north north-easterly direction for approximately 158 metres to grid reference ST 6117 5769, (point J on the Order Map) and continuing in a generally northerly direction for approximately 75 metres to grid reference ST 6116 5776 (point G on the Order Map).

Width: 2 metres from grid reference ST 6114 5753 (point H) to grid reference ST 6116 5776 (point G).
