This order is made by Bath and North East Somerset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

Mr R Hendy has agreed to defray any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.


**BY THIS ORDER:**

1. The public right of way over the land situated at Langridge, Charlcombe and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after seven days from the date of confirmation of this order.
2. No statutory undertakers rights are affected by this order.
3. There shall at the end of seven days from the date of confirmation of this order be a public footpath over the land situate at Langridge, Charlcombe described in Part 2 of the Schedule and shown by a bold broken line on the map attached to this order.
4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

## **SCHEDULE**

### **PART 1**

#### **DESCRIPTION OF SITE OF EXISTING PATH**

The full width of a section of Public Footpath BA5/22 commencing from grid reference ST 7286 6937 (point A on the Order Map) and proceeding in a generally west-northwesterly direction for approximately 178 metres to grid reference ST 7271 6946 (point C on the Order Map).

### **PART 2**

#### **DESCRIPTION OF SITE OF NEW PATH OR WAY**

A public footpath commencing from grid reference ST 7286 6937 (point A on the Order Map) and proceeding in a generally north-northeasterly direction for approximately 84 metres to grid reference ST 7290 6944 (point B on the Order Map) and turning in a generally westerly direction for approximately 203 metres to grid reference ST 7271 6946 (point C on the Order Map).

Width: 2 metres between grid reference ST 7286 6937 (point A on the Order Map) and grid reference ST 7271 6946 (point C on the Order Map).
