BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS BA17/8, BA17/9 & BC14/11, BATH MILL LODGE RETREAT, NEWTON ST LOE) PUBLIC PATH DIVERSION ORDER 2023

The above order, made on 25 May 2023 under section 119 of the Highways Act 1980, will divert:

1. The public footpath running from ST71346468 and proceeding in a generally ENE direction for approx 133m to meet public footpath BC14/11 at ST 71466469; then the full width of the section of Public Footpath BC14/11 commencing from ST71466469 and proceeding in a generally E direction for approx 8m to ST71476469, to a line running from ST71346468 and proceeding in a generally ESE direction for approx 44m to ST71386467, and then turning in a generally NNE direction for approx 61m to ST71416472, and then turning in a generally ESE direction for approx 16m to grid reference ST71426471, and then turning in a generally NE direction for approx 8m to ST71436471, and then turning in a generally SE direction for approx 13m to ST71446471, and then turning in a generally ESE direction for approx 20m to a junction with public footpath BA17/9 at ST71456470, and then continuing in a generally SE direction for approx 3m to ST71456470, and then turning in a generally ESE direction for approx 10m to the City of Bath/Newton St Loe boundary at ST71466470 and then continuing in a generally ESE direction for approx 8m to ST71476469;
2. The public footpath running from a junction with Waltining Lane at ST71516483 and proceeding in a generally E direction for approx 84m to ST71596483, then turning in a generally SW direction for approx 40m to ST71566480, to a line running from a junction with Waltining Lane at ST71516483 and proceeding in a generally E direction for approx 34m to ST71546484, then turning in a generally SSE direction for approx 41m to ST71556480, then turning in a generally E direction for approx 15m to ST71566480,

as shown on the order map.

If the order is sent to the Secretary of State for Environment, Food & Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
