

## NOTICE OF MAKING OF AN ORDER

### HIGHWAYS ACT 1980

#### BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS BA23/8 & BA23/9, WELLOW ROAD, SHOSCOMBE) PUBLIC PATH DIVERSION ORDER 2023

The above order, made on 9 November 2023 under section 119 of the Highways Act 1980, will divert:

1. The public footpath running from a junction with Wellow Road at grid reference ST 7186 5721 and proceeding in a generally south-easterly direction for approximately 75 metres to grid reference ST 7191 5716, to a line running from a junction with Wellow Road at grid reference ST 7188 5721 and proceeding in a generally south-easterly direction for approximately 65 metres to grid reference ST 7192 5717 and then turning in a generally south-westerly direction for approximately 6 metres to the parish boundary at grid reference ST 7192 5176 and then continuing in a generally south-westerly direction for approximately 6 metres to grid reference ST 7191 5716;
2. The public footpath running from a junction with Wellow Road at grid reference ST 7186 5721 and proceeding in a generally southerly direction for approximately 209 metres to grid reference ST 7188 5700, to a line running from grid reference ST 7191 5716 and proceeding in a generally south-southwesterly direction for approximately 158 metres to grid reference ST 7188 5700,

as shown on the order map.

If no such representations or objections are duly made, or if any so made are withdrawn, the Bath and North East Somerset Council may confirm the order as an unopposed order. If the order is sent to the Secretary of State for Environment, Food & Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
