BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS CL9/26, CL9/27, CL9/36 AND CL9/40, BARROW VALE, FARMBOROUGH) PUBLIC PATH DIVERSION ORDER 2021

The above order, made on 11th March 2021, under section 119 of the Highways Act 1980, will divert the public footpaths (FPs):

- CL9/26 running from a junction with A39 Bath Road at grid reference ST 6496 6015 (point S on the order map) and proceeding in a generally S direction for approx 2 metres to a junction with FP CL9/27 at ST 6496 6015 (point N) to a line running from a junction with A39 Bath Road at ST 6497 6016 (point M) and proceeding in a generally SW direction for approx 4 metres to a junction with FP CL9/27 at ST 6496 6015 (point N);
- CL9/27 running from a junction with FP CL9/26 at ST 6496 6015 (point N) and proceeding in a generally SW direction (via point H) for approx 357 metres to ST 6474 5987 (point R) to a line running from a junction with FP CL9/26 at ST 6496 6015 (point N) proceeding in a generally WSW direction for approx 159 metres to a junction with a FP at ST 6482 6009 (Point P) and turning in a generally SSW direction for approx 236 to ST 6474 5987 (point R);
- CL9/36 running from ST 6448 6014 (point A) and proceeding in a generally ENE direction for approx 206 metres to a junction with FP CL9/37 and FP CL9/41 at ST 6468 6019 (point B) and continuing in a generally ENE direction for approx 162 metres to a junction with FP CL9/40 at ST 6483 6024 (Point C) and continuing in a generally ENE direction for approx 60 metres to ST 6489 6025 (point D) to a line running from ST 6448 6014 (point A) and proceeding in a generally E direction for approx 221 metres to a junction with FP CL9/37 at ST 6470 6014 (point G) and continuing in a generally E direction for approx 100 metres to a junction with a FP at ST 6480 6013 (point J) and turning in a generally NE direction for approx 148 metres to ST 6489 6025 (point D); and
- CL9/40 running from a junction with A39 Bath Road at ST 6486 6014 (point E) and proceeding in a generally NNW direction for approx 95 metres to a junction with FP CL9/36 at ST 6483 6024 (point C) and turning in a generally N direction for approx 372 metres to a junction with Public Bridleway CL9/53 at ST 6477 6059 (point F) to a line running from a junction with a new footpath at ST 6482 6009 (point P) and proceeding in a generally NW direction for approx 20 metres across A39 Bath Road to ST 6480 6010 (point K) and proceeding in a generally N direction for approx 28 metres to a junction with a FP at ST6480 6013 (point J) and turning in a generally NNW direction for approx 505 metres to a junction with Public Bridleway CL9/53 at ST 6466 6057 (point L);

as shown on the order map.

If no such representations or objections are duly made, or if any so made are withdrawn, the Bath and North East Somerset Council may confirm the order as an unopposed order. If the order is sent to the Secretary of State for Environment, Food & Rural Affairs for confirmation any representations or objections which have not been withdrawn will be sent with the order.
