**BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATH BA25/5,
MIDDLE TWINHOE, WELLOW) PUBLIC PATH DIVERSION ORDER 2021**

This order is made by Bath and North East Somerset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

Timothy Bamford has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER:

1. The public right of way over the land situate at Middle Twinhoe, Wellow and shown by a bold continuous line on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after seven days from the date of confirmation of this Order.
2. No statutory undertakers rights are affected by this order.
3. There shall at the end of seven days from the date of confirmation of this order be a public footpath over the land situate at Middle Twinhoe, Wellow described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this order.
4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The full width of a section of Public Footpath BA25/5 commencing from a junction with Public Footpath BA25/3 at grid reference ST 7517 5945 (point A on the order map) and proceeding in a generally southwesterly direction for approximately 65 metres to a field boundary at grid reference ST 7512 5941 (point B on the order map) and continuing in a generally southwesterly direction for approximately 3 metres to grid reference ST 7512 5941 (point C on the order map).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A section of public footpath commencing from a junction with Public Footpath BA25/3 at grid reference ST 7517 5945 (point A on the order map) and proceeding in a generally south southeasterly direction for approximately 4 metres to a field boundary at grid reference ST 7518 5945 (point D on the order map) and turning in a generally southwesterly direction for approximately 62 metres to grid reference ST 7513 5941 (point E on the order map) and turning in a generally westerly direction for approximately 7 metres to grid reference ST 7512 5941 (point C on the order map).

Width: 2 metres between grid reference ST 7517 5945 (point A on the order map) and grid reference ST 7512 5941 (point C on the order map).

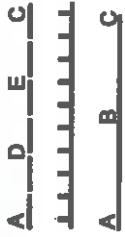
