BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATHS BA27/19 AND BA27/20, RIVER TERRACE AND MEMORIAL PARK, KEYNSHAM) PUBLIC PATH DIVERSION ORDER 2019

This order is made by Bath and North East Somerset Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owners of the land crossed by the footpaths described in paragraph 1 of this order it is expedient that the line of the paths should be diverted.


BY THIS ORDER:

1. The public rights of way over the land situate at River Terrace and Memorial Park, Keynsham and shown by bold continuous lines on the map contained in this order and described in Part 1 of the Schedule to this order shall be stopped up after seven days from the date of confirmation of this Order.
2. Notwithstanding this order Wales & West Utilities Ltd and Virgin Media shall have the following rights over the land referred to in paragraph 1 namely: where immediately before the date on which the footpath is diverted there is apparatus under, in, on, over, along or across it belonging to Wales & West Utilities Ltd or Virgin Media for the purpose of carrying out their undertaking, Wales & West Utilities Ltd and Virgin Media shall continue to have the same rights in respect of the apparatus as they then had.
3. There shall at the end of seven days from the date of confirmation of this order be public footpaths over the land situate at River Terrace and Memorial Park, Keynsham described in Part 2 of the Schedule and shown by bold broken lines on the map attached to this order.
4. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.



SCHEDULE

PART 1

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The full width of the section of public footpath commencing from a junction with Public Footpath BA27/20 at grid reference ST 6554 6840 (point A on the Order Map) and proceeding in a generally southeasterly direction for approximately 78 metres to a junction with Public Footpath BA27/19 at grid reference ST 6559 6834 (point B on the Order Map).

The full width of the section of public footpath commencing from a junction with Public Footpath BA27/19 at grid reference ST 6554 6840 (point A on the Order Map) and proceeding in a generally southerly direction for approximately 47 metres to a junction with unnumbered footpath at River Terrace at grid reference ST 6554 6835 (point C on the Order Map).

The full width of the section of public footpath commencing from a junction with unnumbered footpath at River Terrace at grid reference ST 6555 6833 (point D on the Order Map) and proceeding in a generally south-southeasterly direction for approximately 175 metres to a junction with Public Footpath BA27/19 at grid reference ST 6559 6816 (point E on the Order Map).

The full width of the section of public footpath commencing from grid reference ST 6563 6823 (point F on the Order Map) and proceeding in a generally south-southeasterly direction for approximately 58 metres to a junction with Public Footpath BA27/19 at grid reference ST 6564 6817 (point G on the Order Map).

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A section of public footpath commencing from a junction with Public Footpath BA27/74 at grid reference ST 6553 6842 (point H on the Order Map) and proceeding in a generally east-northeasterly direction for approximately 4 metres to grid reference ST 6554 6842 (point J on the Order Map) and turning in a generally southerly direction for approximately 35 metres to a junction with a new public footpath at grid reference ST 6555 6839 (point K on the Order Map) and turning in a generally west-southwesterly direction for approximately 1 metre to a junction with unnumbered footpath at River Terrace at grid reference ST 6554 6839 (point L on the Order Map).

Width: 2 metres between grid reference ST 6553 6842 (point H on the Order Map) and grid reference ST 6554 6839 (point L on the Order Map).

A section of public footpath commencing from a junction with a new public footpath at grid reference ST 6555 6839 (point K on the Order Map) and proceeding in a generally northeasterly direction for approximately 9 metres to grid reference ST 6556 6839 (point M on the Order Map) and turning in a generally easterly direction via steps for approximately 9 metres to grid reference ST 6556 6839 (point N on the Order Map) and turning in a generally southerly direction via steps for approximately 16 metres to grid reference ST 6557 6838 (point P on the Order Map) and turning in a generally northeasterly direction for approximately 42 metres to a junction with Public Footpath BA27/19 at grid reference ST 6560 6839 (point Q on the Order Map).

Width: 1.1 metres between grid reference ST 6555 6839 (point K on the Order Map) and grid reference ST 6556 6839 (point N on the Order Map).

1.2 metres between ST 6556 6839 (point N on the Order Map) and ST 6557 6838 (point P on the Order Map).

3.5 metres between grid reference ST 6557 6838 (point P on the Order Map) and grid reference ST 6560 6839 (point Q on the Order Map).

A section of public footpath commencing from a junction with unnumbered public footpath at River Terrace at grid reference ST 6556 6834 (point R on the Order Map) and proceeding via steps in a generally south-southeasterly direction for approximately 16 metres to grid reference ST 6556 6832 (point S on the Order Map) and turning in a generally northerly direction for approximately 13 metres to grid reference ST 6556 6834 (point T on the Order Map) and turning in a generally easterly direction for approximately 14 metres to grid reference ST 6558 6834 (point U on the Order Map) and turning in a generally southerly direction for approximately 191 metres to a junction with Public Footpath BA27/19 at grid reference ST 6559 6816 (point V on the Order Map).

Width: 1.8 metres between grid reference ST 6556 6834 (point R on the Order Map) and grid reference ST 6556 6832 (point S on the Order Map).

2 metres between grid reference ST 6556 6832 (point S on the Order Map) and grid reference ST 6556 6834 (point T on the Order Map).

Graduating at a constant rate from 2 metres at grid reference ST 6556 6834 (point T on the Order Map) to 3.5 metres at grid reference ST 6558 6834 (point U on the Order Map).

2 metres between grid reference ST 6558 6834 (point U on the Order Map) and grid reference ST 6559 6816 (point V on the Order Map).

A section of public footpath commencing from grid reference ST 6563 6823 (point F on the Order Map) and proceeding in a generally southerly direction for approximately 58 metres to a junction with Public Footpath BA27/19 at grid reference ST 6563 6817 (point W on the Order Map).

Width: 2 metres between grid reference ST 6563 6823 (point F on the Order Map) and grid reference ST 6563 6817 (point W on the Order Map).
