

COMMONS ACT 2006 — SECTION 15(1)**Notice of an application for the registration of land as a Town or Village Green**

To: Every reputed owner, lessee, tenant or occupier of any part of the land described below, and to all others whom it may concern.

Application Reference: TVG15/2

Application has been made to **Bath and North East Somerset Council** at **Civic Centre, Market Walk, Keynsham, BS31 1FS** by **Mr Hugh Baker, Chairman Bathford Parish Council, c/o 54 Bathford Hill, Bathford, Bath, BA1 7SN** under section 15(1) of the Commons Act 2006 and in accordance with the Commons (Registration of Town or Village Greens) (Interim Arrangements) (England) Regulations 2007. The Application seeks the inclusion in the register of town and village greens of the land described in the Schedule below which is claimed to have qualified for registration as a town or village green in **March 2015** by virtue of a **significant number of inhabitants of the locality of the parish of Bathford having indulged as of right in lawful sports and pastimes for a period of at least 20 years as witnessed by the signed statements appended to the Application showing use for activities including child's play, bird watching and dog walking.**

The Application, which includes a plan of the land proposed for registration may be inspected at Public Rights of Way, Bath and North East Somerset Council, Civic Centre, Market Walk, Keynsham, BS31 1FS between the hours of 08:30 and 17:00 on Monday to Friday (excluding public holidays). Copies of the documents may also be inspected at The One Stop Shop, Manvers Street, Bath, BA1 1JG between the hours of 08:30 and 16:30 on Monday to Friday (excluding public holidays).

If the registration authority is satisfied that the land described below qualifies for registration as a town or village green, it will so register the land.

Any person wishing to object to the registration of the land as a town or village green should send a statement of the facts on which the objection is based to **Graeme Stark of Bath and North East Somerset Council, Public Rights of Way, Lewis House, Manvers Street, Bath, BA1 1JG** on or before **4th February 2015**. Any representations that are to be taken into account by the Authority in reaching a decision on the Application cannot be treated as confidential and will be copied to the applicant for comment and may be disclosed to other interested parties.
