

COMMONS ACT 2006 — SECTION 15(1)

Notice of an application for the registration of land as a Town or Village Green

To: Every reputed owner, lessee, tenant or occupier of any part of the land described below, and to all others whom it may concern.

Application Reference: TVG13/2

Application has been made to **Bath and North East Somerset Council at Riverside, Temple Street, Keynsham, BA31 1LA** by **Mark F. Collins, Jane E. Neech, Rachel Tidcombe and Leonard W. Sheen of Mendip Ho!, Greyfield Road, High Littleton, Bristol, BS39 6XZ** under section 15(1) of the Commons Act 2006 and in accordance with the Commons (Registration of Town or Village Greens) (Interim Arrangements) (England) Regulations 2007. The Application seeks the inclusion in the register of town and village greens of the land described in the Schedule below which is claimed to have qualified for registration as a town or village green on **19th July 2013** by virtue of **a significant number of inhabitants of the neighbourhood of Greyfield having indulged as of right in lawful sports and pastimes for a period of at least 20 years as witnessed by the signed statements appended to the Application showing use for activities including dog walking, rambling/walking, nature watching, sledging and snowballing and educational purposes.**

The Application, which includes a plan of the land proposed for registration may be inspected at Public Rights of Way, Bath and North East Somerset Council, Riverside, Temple Street, Keynsham, BA31 1LA between the hours of 08:30 and 16:30 on Monday to Friday (excluding public holidays). Copies of the documents may also be inspected at The One Stop Shop, The Hollies, High Street, Midsomer Norton, BA3 2DP between the hours of 08:30 and 16:30 on Monday to Friday (excluding public holidays).

If the registration authority is satisfied that the land described below qualifies for registration as a town or village green, it will so register the land.

Any person wishing to object to the registration of the land as a town or village green should send a statement of the facts on which the objection is based to **Graeme Stark of Bath and North East Somerset Council, Riverside, Temple Street, Keynsham, BA31 1LA** on or before **10th September 2013**. Any representations that are to be taken into account by the Authority in reaching a decision on the Application cannot be treated as confidential and will be copied to the applicant for comment and may be disclosed to other interested parties.

Approximately 7.22ha of land comprising of two fields between Greyfield Woods and Greyfield Road and adjacent to Greyfield Common in High Littleton which are approximately centred upon grid references ST 6405 5850 and ST 6424 5839 and which are known as Robin Candy's Fields and also referred to as Greyfield Fields and The Sheppard's Fields.
