NOTICE OF CONSULTATION ON THE REVISED FRESHFORD AND LIMPLEY STOKE NEIGHBOURHOOD PLAN PRE-SUBMISSION DRAFT

CONSULTATION PERIOD: Saturday 11th January 2014 to Saturday 22nd February 2014

Freshford (Bath and North East Somerset) and Limpley Stoke (Wiltshire) Parish Councils ('the Councils') hereby **give notice** of a period of **public consultation** on the revised Freshford and Limpley Stoke Neighbourhood Development Plan ('the Plan') Pre-Submission Draft in accordance with the provisions of Regulation 14 of The Neighbourhood Planning (General) Regulations 2012 and the Localism Act 2011

The Plan is being produced by the Councils to guide future development within the Neighbourhood Plan Area – the Parishes of Freshford and Limpley Stoke.

A Management Group was formed in 2012 to guide preparation of the Plan; this included a programme of engagement with the local community to identify those issues most important to local people. The issues raised during this period of engagement have informed the production of the revised Plan Pre-Submission Draft upon which the Parish Councils are now required to invite representations before submitting a final Draft Plan for independent examination to the two lead Authorities of Bath and North East Somerset Council and Wiltshire Council.
