The next stage of the Neighbourhood Plan process has arrived. The thinking so far has been summarized in a leaflet - *'Making Progress'* - which incorporates a questionnaire so that residents can give their feedback. Everyone in the community is warmly encouraged to let us know what they think.

*'Making Progress'* will be delivered to every household in Freshford and Limpley Stoke between 20<sup>th</sup> and 22<sup>nd</sup> February. You are asked to answer the questions in the leaflet and then put the leaflet in the supplied polythene envelope outside your house for collection. The card delivered with the leaflets shows the day on which they will be collected - between 4<sup>th</sup> and 6<sup>th</sup> March.

We are keen to hear from as many people as possible - including younger people and others who have a stake, for example if they work in the neighbourhood. So, if you have not received a copy by 23<sup>rd</sup> February or require a further copy, they will be available from the Galleries Shop.

To support the distribution of *'Making Progress'* we will again be holding the popular Neighbourhood Plan Surgeries from 10.30 to 12.30 on Saturday 23<sup>rd</sup> February, at The Hop Pole Inn, and on Saturday 2<sup>nd</sup> March, at Freshford Village Memorial Hall. You will be able to come along and speak to members of the Neighbourhood Plan team and ask any questions you may have about the leaflet/questionnaire and about the Neighbourhood Plan process.

*'Making Progress'* is emphatically *not* the Neighbourhood Plan but is an important part of the process. When the Plan itself is submitted for review we will need to show the degree of support in the community for the proposals it contains, so your views count. If you are broadly happy with the proposals, or if you have specific points you would like to make, it is important that you should say so. Your comments do not commit you in any way but will help your Councils decide what should go forward in our final Neighbourhood Plan.

Simply put the completed questionnaire - the whole leaflet - in the supplied polythene envelope and leave it outside your home, somewhere where it can easily be seen, on the date shown.

If for any reason your completed questionnaire is not collected by the evening of Wednesday 6th March, or you were not given a collection date, you can hand them in at the Galleries Shop, St. Peter's Church, St. Mary's Church, The Hop Pole, The Inn at Freshford or to any Parish Councillor.

If there's anything you would like to discuss, or any questions you would like clarified, do come along to the Neighbourhood Plan Surgery to be held outside Freshford Memorial Hall on Saturday 2nd March from 10.30 to 12.30. There'll be members of the Neighbourhood Plan management group and representatives of the various working groups in attendance. This represents a response of 57% of parishioners. These replies have been analysed and any additional comments recorded. These results are proving enormously helpful to the Working Groups and the Neighbourhood Plan Management Group in their on-going discussions.

The Draft Neighbourhood Plan has evolved considerably since our initial discussions back at the beginning of last year. A great deal of work, investigation and discussion has gone into the process and we can be proud of the resulting document which reflects the wishes of residents while conforming to wider planning regulations.

We are now reaching an important stage in the process.

The Plan at this stage is still only a draft. It will be published on 1st July for a 6-week community consultation. Further comments will be welcome and will be carefully considered by the Management Group, which of course comprises representatives of both Parish Councils, before being submitted to the Lead Councils - B&NES and Wiltshire - for Formal Validation. After that, there is a period of Formal Consultation by the Lead Councils, followed by the external Examination. Finally, we hope to bring the Neighbourhood Plan to the community for a Referendum before the end of this year (though the actual date does rather depend on matters outside our control).

In the meantime we attach the Formal Notice concerning this consultation. We'll be emailing further information in the next few days - how you can view the Draft Neighbourhood Plan and associated documents, both online and as hard copy; where you can come to discuss the Draft Plan and how to submit any further comments you may have.

In July 2013 the Freshford and Limpley Stoke community engaged in a widespread and valuable local consultation on the draft Neighbourhood Plan. At the time we hoped that the consultation would be complete by the end of August but we now realise this was over-optimistic. This email is to help you understand where the process has got to and what now needs to happen.

A key stage in the development of our Neighbourhood Plan is the approval by Bath and North East Somerset Council and Wiltshire Council of the Neighbourhood Area Designation. Because our Plan spans two counties we need the approval of both councils. This approval needs to be given before formal local consultation can take place. The Management Group has yet to receive confirmation that the Order of Designation has been 'signed off' by the two Councils.

The need to prepare a Sustainability Appraisal (SA) has further added to the delay. This is an assessment of the social, environmental and economic effects of a plan, and 'reasonable alternatives' to a plan. It helps to ensure that decisions are made that contribute to achieving sustainable development. The early advice received by the NP Management Group suggested that a SA was not really necessary. (The Department of Communities and Local Government, which provides grants for the development of Neighbourhood Plans, specifically excludes SAs from its grant support.) However B&NES and Wilts have now decided that they do require a full SA, which is a considerable piece of extra work. The SA has to be approved by certain statutory authorities before it can be submitted for local consultation.

These delays are frustrating and have involved the Management Group and others in considerable extra work (though we have managed to obtain a grant to retain a consultant to help us prepare the SA) but every cloud has a silver lining – the resulting Neighbourhood Plan will be a *better, more representative* document as a result.

The consultation process held in July, although jumping the gun as far as the formal legal process is concerned, has been immensely helpful in clarifying the views of residents. The Neighbourhood Plan needs to reflect the views of the community as a whole. The Management Group has endeavoured to channel the ideas generated from open meetings, the questionnaire and the working groups into a coherent Plan. It was difficult for residents to comment in the abstract but once we had published a draft Plan, people were able to make more specific suggestions – and many of the points made have been *pure gold!*

The point is also worth making that the Neighbourhood Plan is not a plan necessarily reflecting the wishes of the parish councils of Freshford and Limpley Stoke but is intended to reflect the majority wishes of residents of the two villages. Clearly we would wish the plan to be in a form which has the support of the two parish councils but the key task of the Management Group has been to focus on the expressed wishes of the community. The Management Group is using the delay to revise the draft Plan so that it will benefit from these submissions. When the Neighbourhood Area designation has been approved and the Sustainability Appraisal has been produced and approved as required, we will be publishing this revised draft Plan for a further 6-week consultation by the community.

Residents need to understand, though, that the main reason why this revised draft may still not please everyone is because a Neighbourhood Plan *must* conform to local Core Strategies (the lead Councils' planning frameworks) and to the National Planning Policy Framework and should plan positively to support local development albeit within the parameters of Green Belt policy. This means, for instance, that our Neighbourhood Plan cannot overrule planning policy on local 'brownfield' sites like Freshford Mill or the Rentokil site in Pipehouse if these fall within the emerging B&NES Core Strategy. Despite this, we firmly believe that our Neighbourhood Plan will genuinely help the community to shape local development to meet our needs and aspirations.

So what of the schedule from here on?

It is outside our control but we are unlikely to be able to publish the revised draft Plan for formal consultation before Christmas – so that will be a treat in store for the New Year! Do please get in touch with any member of the Management Group should you have any questions to ask.

The Neighbourhood Plan Management Group has been extremely busy over the last few months - revising the Draft Plan following comments received as a result of the consultation held in July and August last year and dealing with the surprising amount of supporting documentation required.

Now we are in a position to publish a Revised Draft Plan and warmly invite you to let us have any further comments during a formal 6-week consultation from 11<sup>th</sup> January to 22<sup>nd</sup> February.

**This is the last stage at which residents can contribute to the drafting of our Plan, so please take the time to let us have any comments you may have.**

The Plan will then be considered by various statutory authorities, amended if necessary and finally submitted to an independent Examiner. All being well, this should lead to a referendum in the autumn when the community will have the opportunity to vote. Once adopted, the Neighbourhood Plan will ensure that our wishes are taken into consideration when planning decisions are made.

This Revised Draft differs from the version published last summer in several respects, the main ones being:

- The 'Village Envelopes' have been rethought, leaving out Pipehouse and the brownfield sites at Freshford Mill and Rentokil. They have been renamed 'Settlements' as this is a term used by planning authorities.
- The idea of pressing for traffic lights on the A36 has been dropped.
- The suggested new footpath from St. Mary's Church down to the shop has also been dropped.
- 'Infill development' has been more clearly defined.
- Prospective numbers of new market and affordable housing have also been clarified.

The Plan will be displayed at open surgeries from 10.00 to 12.00 a.m. at the Limpley Stoke Hotel on 11<sup>th</sup> January, and at Freshford Village Memorial Hall on 18<sup>th</sup> January. Do join us if you can.

The Plan and related documents will also be on the [JointNeighbourhood Plan](#) section of the FreshfordVillage.com website and a printed copy will be available for inspection at The Galleries Shop.

We are very grateful to the large number of residents who have put in a great deal of work on this Plan. Now is the time to let us have your final thoughts.

We've had two well-supported open surgeries and a number of residents have taken the trouble to submit further comments, helping the Neighbourhood Plan Management Group get the details right.

**Now, though, the consultation period is coming to an end. This is the last stage at which residents can contribute to the drafting of our Plan, so please let us have any comments you may have on or before 22 February.**

The Plan will then be considered by various statutory authorities, amended if necessary and finally submitted to an independent Examiner. All being well, this should lead to a referendum in the autumn when the community will have the opportunity to vote. Once adopted, the Neighbourhood Plan will ensure that our wishes are taken into consideration when planning decisions are made.
