#### Government Guidance

On 28 August, DCLG launched guidance on neighbourhood planning as part of the national planning practice guidance webbased resource. This is the first time government planning practice guidance has been available online in an up-to-date, usable and accessible way.

The new tool is in <u>test mode</u> and is open for comment: none of the current planning practice guidance will be cancelled until the final online guidance is in place and live later in the autumn.

Any neighbourhood plan or order submitted to the local planning authority before the new guidance is issued will be able to rely on the current guidance suite.

The guidance covers issues that we know from your feedback are of interest to many communities, from designating areas (<a href="http://bit.ly/141CI1I">http://bit.ly/141CI1I</a>) to the weight of emerging plans and the relationship between neighbourhood plans and local plans (<a href="http://bit.ly/1dp516V">http://bit.ly/1dp516V</a>). It is vital reading.

The on-line resource will be open for public comment until 9 October with a final go-live planned for the autumn.

# Plans, Plans, Plans

The movement keeps growing as over half of local authorities have now received applications to designate areas (see map on page 4). Herefordshire lead the way with 40+ applications, Leeds 20, Mid Sussex and Westminster 19. ## **Independent Examiners Panel**

In July, Planning Minister Nick Boles attended the launch of the Neighbourhood Planning Independent Examiner Referral Service established by the Royal Institute of Chartered Surveyors.

The panel provides access to impartial and qualified independent examiners. It is the local authority's responsibility to appoint the examiner, with the consent of the neighbourhood forum or parish council.

Ron is part of the group leading the Uppingham neighbourhood plan in Rutland, a market town, population of 4500 with around 1800 dwellings.



Ron, with members of the Task Group, has been tirelessly consulting residents and businesses over the last 18 months.

The Uppingham approach has included regular newsletters, community voting, classroom discussions, 'Meet the Developer' events and one-on-one engagement with the housebound and the elderly.

Ron also made presentations to the local Business and Neighbourhood groups. In addition he has participated in national events organised by DCLG, Action for Market Towns (AMT) and the Design Council.

In the first three months, over £1m in grants has been awarded, along with expert support packages for over 100 neighbourhood planning groups.

Please remember to read the guidance on the My Community Rights web pages (<a href="http://bit.ly/1bPSI9w">http://bit.ly/1bPSI9w</a>). Some of the lessons learned are, avoid:

- applying for ineligible items
- applying for grant and direct support to cover the same tasks
- applying for larger amounts than £7,000 without explaining what specifically the grant element will cover.

Awards for All gives groups a quick and easy way to get small Lottery grants of between £300 and £10,000.

They fund a wide range of community projects aimed at developing skills, revitalising the local environment and enabling people to become more active citizens.
