COUNCIL'S RESPONSE TO ID/3: MATTER 9 – NATURAL AND BUILT ENVIRONMENT

Issue: Whether the policies in the Placemaking Plan will sustain and enhance the significance of the city's heritage assets and green infrastructure as set out in Policy B1: Bath Spatial Strategy.

Q1. Are the management of development policies justified and consistent with the Bath Spatial Strategy and vision contained in the CS and national policy?

1. The Core Strategy is adopted policy and is conformity with NPPF, and it forms the basis on which the production of the Placemaking Plan was produced. It is the Council's view that the Placemaking Plan is in conformity with the Core Strategy, including the Bath Spatial Strategy and the vision.
2. To inform the production of the Placemaking Plan, the Council commissioned a suite of further evidence to complement the existing body of evidence related to the city's heritage assets and green infrastructure. These include, but are not limited to, the following documents:
 - WHS Attributes (CD/PMP/B8)
 - WHS Setting SPD (CD9/W1)
 - Bath City-Wide Character Appraisal(CD4/UDL1)
 - Building Heights Strategy(CD/PMP/B8)
 - Draft Conservation Area Character Appraisals(CD/PMP/B13/1-6)
 - Morphology Study (CD/PMP/B3)
 - Historic Overview of Development Sites (CD/PMP/B6)
 - Green Infrastructure Strategy(CD/PMP/G27)
 - Public Realm and Movement Strategy(CD4/UDL13)
 - Pattern Book (CD/PMP/B14/1-3)
 - Natural Environment Evidence Base for the Enterprise Area Masterplan (CD/PMP/B11)
 - Bath Building Height Strategy (CD4/UDL2-5)
3. This robust and comprehensive evidence base has informed the preparation of both the site allocations and the development management policies of the Placemaking Plan.

4. It is useful to note the representation received from Historic England (Rep No. 0279-01) (see Appendix) which states:

‘Historic England recognise the significant merits of this impressive Plan that demonstrates a thorough and robust positive strategy for the conservation of the District’s historic environment, and the great care and attention taken in seeking to sustain the OUV of the Bath WHS.

It is apparent an informed understanding and consideration of the significance of the District’s cultural heritage has shaped the Plan and will inform its future implementation’

5. In addition, the development management policies as well as the development requirements and design principles contained in the site allocations were subject to the Sustainability Appraisal that tested the appropriateness of the policies against a set of sustainability objectives (CD/PMP/G9). ‘Table 4: Development Management Policies’ and objectives 6, 7 and 8, are of particular relevance. These were used to shape the Core Strategy. This process demonstrates that the policies are justified and consistent with the approach set out in the Core Strategy.
6. The table below illustrates the policy criteria from Policy B1 of the Core Strategy that relate to heritage assets and green infrastructure, and cross references these to the policies in the Placemaking Plan that will ensure that these elements are sustained and enhanced:
