PLACEMAKING PLAN: Analysis of weight to be applied to Placemaking Plan policies (June 2017)

Introduction

In accordance with the NPPF, para 216, the degree of weight to be given to the Placemaking Plan policies in determining applications from the day of publication and prior to its adoption is related to:

- the stage of preparation of the emerging plan;
- the extent to which there are unresolved objections to relevant policies;
- the degree of consistency of relevant policies in the emerging plan with the NPPF

Following the Examination hearings the Inspector issued her Interim Statement (document ID/17) and advised the Council of her recommended Main Modifications required to make the plan sound (document ID/18), thereby addressing objections and ensuring consistency with the NPPF. The Main Modifications and Minor Proposed Changes (discussed at the Hearings) were subject to public consultation from early January 2017.

Having considered the representations received through the consultation, the Inspector has now issued her Final Report and found the Placemaking Plan sound subject to the Main Modifications. Receipt of the Inspector's Report represents the end of the Placemaking Plan Examination. The Inspector's Report and the recommended modifications will be discussed at Full Council on 13th July 2017 and adoption of the Placemaking Plan will be considered.

Until the Placemaking Plan has been formally adopted by the Council all Placemaking Plan policies, including Core Strategy policies to be superseded through the Placemaking Plan (which will retain the same policy reference number), will be given substantial weight. Once the Placemaking Plan is adopted, these policies will be afforded full weight. Full weight in decision-making continues to apply to all other Core Strategy policies not superseded through the Placemaking Plan.

The table below sets out each policy with its respective weighting attributed by the LPA colour-coded as follows:

- **full weight** = Adopted Core Strategy policies not superseded through the Placemaking Plan
- substantial weight = all Placemaking Plan policies including Core Strategy policies to be superseded through the Placemaking Plan

Please note that the analysis may be subject to challenge through the process of determining planning applications.
