1. Introduction

This report sets out our annual accounts for the year to provide transparent information about income from parking charges and the enforcement of civil parking on- street and off-street (car parks).

We strive to provide services that help improve public safety, reduce congestion and keep the road network moving. We aim to improve air quality through a major shift to sustainable transport, walking and cycling and incentives to reduce the use of more polluting vehicles, aligning with the vision and outcomes from our Journey to Net Zero Transport Strategy, to promote sustainable transport and reducing CO2 emissions and the intrusion of vehicles, particularly more polluting vehicles, into our historic urban centres.

January 2022 saw the introduction of emission based resident parking permits in Bath linking the cost of resident permits to a vehicle's emissions for the first time. Charges are based on a vehicle's carbon dioxide (CO2) emissions, in line with the DVLA Vehicle Excise Duty (VED) classifications. Where no VED emissions rating is available, including all vehicles registered before 2001, the charge is based on engine capacity.

Our emissions based variable charges have been developed to improve air quality through a major shift to sustainable transport, walking and cycling and incentives to reduce the use of more polluting vehicles to secure the safer movement of pedestrian traffic on the highway by reducing the public health risks posed to them by air pollution.

During the summer of 2023, we consulted on proposals to introduce emission-based car park charges for Bath car parks in continued support of the aims outlined above. The proposals were approved and introduced in September 2023 on a phased basis.

Further proposals to consider the extension of emissions-based charging to car parks in Keynsham, Midsomer Norton and Radstock along with on street parking locations in Bath were approved as part of the 24/25 budget planning process in March 2024, with expectations for further public consultation on emerging proposals in 2024.

2. On street and Off street - Penalty Charge Notices (PCN's) issued and paid

2.1. Why we enforce parking restrictions

We enforce parking restrictions to promote compliance with the restrictions in place as set out in legally approved Traffic Regulation Orders.

This is important for pedestrian safety, to reduce congestion and to meet our Network Management duty to keep the road network moving, supporting active travel and more sustainable modes of transport. Parking restrictions also help manage the limited kerb space available for parking, given the limitations of our road network, especially in Bath as a historic Georgian city and UNESCO World Heritage site.

We take a fair and proportionate approach to parking enforcement. We engage with motorists to provide education and issue Penalty Charge Notices (PCN's) as part of our overall approach to promote compliance with restrictions and provide effective enforcement.

Whilst enforcement action through the issue of PCN's may generate income to the council, our aim is to ensure compliance with restrictions rather than raising revenue.

2.2. Legal Provisions

We undertake the administration and enforcement of Civil Enforcement in accordance with the following legislation and guidance:

Legislation sets out the statutory process for how PCN's are administered and enforced when issued. We will consider challenges and representations sent to us including any mitigating circumstances on a case by case basis in accordance with the statutory process and the council's Enforcement and Cancellation policy at

The level of the Penalty Charge is set by national legislation and not by the Council. The amount of a Penalty Charge for contraventions on-street or off-street (Council managed car parks) will vary between £50 (lower level) and £70 (higher level) depending on the contravention reason and it's considered severity. The Penalty Charge for contravening a bus lane, or bus gate, is set at £70 (higher level).

PATROL provide resources to support independent adjudicators and their staff, who together comprise the Traffic Penalty Tribunal (TPT).

6. Permit demand and pressure

We provide resident parking schemes which enable residents and some businesses (subject to criteria and location) to purchase on street parking permits. Whilst a space is not guaranteed, having a permit as a member of the scheme enables residents to access parking near to their home or for local businesses, their business premise and helps prevent commuter parking and the inconvenience this causes.

On street kerb space is significantly limited across many of our resident permit schemes as the table below highlights with the level of pressure for parking compared to the estimated available spaces for each zone as of 31st March 2024.

The 'Parking Demand and Pressure' column shows the current pressure for parking in a zone given the number or permits purchased compared to the estimated number of spaces in a zone.

The 'Potential demand' column shows the potential demand for the estimated number of spaces in a zone in the event all those that are eligible purchase a 1st permit and 50% purchase a 2nd permit (where available).

8. Bus Lane PCNs

Bus Lanes are located in Bath, (see https://www.bathnes.gov.uk/bus-lanes-bath) and are important to help pedestrian safety, reduce congestion and to meet our Network Management duty. The topography of Bath and it's status as a historic Georgian city and UNESCO World Heritage site creates a challenging network environment and enforcement of Bus Lanes helps ensure we can prioritise the free flow of public transport and public service vehicles.

As mentioned above, the level of the Penalty Charge is set by national legislation and not by the Council. The Penalty Charge for contravening a bus lane, or bus gate, is set at £70 (higher level).

8.1. Number of PCNs

This table shows the number of Bus Lane PCN's issued, the number of appeals received by the council and the level of appeals the council 'allowed' having considered the mitigating circumstances provided on a case by case basis, this resulting in the cancellation of the PCN.

The results demonstrate the council's compliance with the Secretary of State's requirement not to fetter its discretion with 65% of appeals on average resulting in a successful outcome

9. Appeals to the Traffic Penalty Tribunal

In accordance with the statutory legal process for PCN's, in the event formal representations made to the council to appeal a PCN are rejected, the owner/keeper of the vehicle has the right to appeal to the independent adjudicator of the Traffic Penalty Tribunal (TPT). Information about TPT can be found at https://www.trafficpenaltytribunal.gov.uk/

The table below shows that the level of appeals made to TPT and outcomes in 2023/24. This includes combined data for On Street, Off Street and Bus Lane PCN's. The rate of appeal to TPT remains very low at 0.2% of the total number of PCN's issued. This demonstrates the council's fair approach to enforcement.


- **30 cases (49%)** related to new evidence not previously provided to the council. For example, private hire vehicle holders providing evidence of their exemption in the form of private hire licences; or where a motorist provides evidence vehicle had been sold.
- 6 cases (10%) related to use of discretion upon further independent review of mitigating circumstances.
- 25 cases (41%) were cancelled due to administrative error. In these instances, feedback is provided to support learning, continuous improvement and enhance service and quality standards.

10. Blue Badges


Parking Services process applications for Blue Badges. This is a vital service which helps a Blue Badge holder park closer to their destination to access goods and services and park in more places for a longer period. In some cases, parking is free.

The scheme is open to both drivers and passengers with severe mobility problems caused by visible and non-visible disabilities. To be eligible for a Blue Badge you need to meet criteria set out by the government. This total number of Blue Badges issued in 2023/24 are 3423. The distribution across the year is show in the following chart.
