High Littleton & Hallatrow Neighbourhood Plan Consultation Statement

Introduction

High Littleton Parish Council, as qualifying body defined by the Localism Act 2011, has submitted its Neighbourhood Plan to Bath & North East Somerset Council for independent examination. This Consultation Statement meets the requirements of the Neighbourhood Planning (General) Regulations 2012 Regulation 15 and Regulation 14. It also contains an outline of earlier consultations and community engagements carried out while developing the High Littleton & Hallatrow Neighbourhood Plan.

Section 15(2) of the Regulations states that a Consultation Statement is a document which:

- contains details of the persons and bodies who were consulted about the proposed neighbourhood development plan;
- explains how they were consulted;
- summarises the main issues and concerns raised by the persons/bodies consulted; and
- describes how these issues and concerns have been considered and, where relevant, addressed in the proposed neighbourhood development plan.

This Consultation Statement summarises all statutory and non-statutory consultation undertaken with the local community and with other relevant bodies and stakeholders in developing the draft Neighbourhood Plan. In particular it describes how some of the concerns that arose during the statutory pre-submission consultation have been addressed and what changes have been made to convert the draft Neighbourhood Plan into the proposed Neighbourhood Plan.

Neighbourhood Plan Working Group and Communications Plan

The Plan was prepared by volunteer residents and members of High Littleton Parish Council (the Neighbourhood Plan Working Group) with support from B&NES Council Planning Department. Community engagement, through consultation and awareness raising, has been integral to the development of our Neighbourhood Plan in accordance with the Communications Plan at Appendix A.

Community Engagement

Awareness raising to encourage local involvement was initially through articles in the Parish magazine ('News & Views') and social media. This led to the first Neighbourhood Plan community event in November 2016 with a well-attended "drop in" meeting to determine the key areas for inclusion in the plan. A full report from this event is included as Appendix B.

Development of the Neighbourhood Plan was paused in 2018 as it was decided to wait for the B&NES Local Plan to be agreed to ensure the Neighbourhood Plan would be consistent with local planning policy. The COVID pandemic caused further delay, preventing further community events from being held. In 2022, it was decided to restart work on the Neighbourhood Plan and a new working group was formed from Parish Councillors and residents. A second "drop in" meeting was held in January 2023 to allow residents an opportunity to review and comment on a mature draft of the plan, including policies and objectives. Following the second community event, the plan was revised prior to starting the formal Regulation 14 consultation process following Parish Council endorsement in April 2023. A full report from the second "drop in" is included as Appendix C.

Regulation 14 consultation

In accordance with Neighbourhood Planning Regulation 14, High Littleton Parish Council undertook a public consultation on its Pre-Submission Neighbourhood Development Plan from 13th June 2023 until 25th July 2023. The statutory bodies consulted are listed at Appendix D. Each body was sent an email that explained the purpose of the consultation, included links to the Neighbourhood Plan and supporting documents and provided a questionnaire to assist with responding. Additionally, the local community was encouraged to respond to the consultation through local advertising (via the parish and school newsletters, social media and council website). Copies of these are included in Appendix D.

In total 25 comments were received from 12 consultees. No comments were received from residents within the Parish. Informally, feedback was provided by some residents to acknowledge that they were content that they had an opportunity to contribute to the plan at community engagement events.

The responses to the consultation are summarised at Appendix E along with details of how comments have been actioned where appropriate.

Conclusion

The draft High Littleton Parish Council has completed a consultation on the High Littleton & Hallatrow Neighbourhood Plan in accordance with legislation following a period of community engagement. The plan is now submitted to the local planning authority to appoint an independent examiner.

Executive Summary

- 1. In order to complete a Neighbourhood Plan there was a requirement for wide ranging community engagement within the Parish. Preparation for the initial Neighbourhood Drop-in Launch started in September 2016 with publicity through a flyer delivered to each household in the Parish and posters displayed in High Littleton and Hallatrow prior to the event. A community questionnaire was prepared to seek their views of residents on a wide range of subject areas. While the views canvassed included issues outside the scope of the Neighbourhood Plan it would provide a holistic record of the issues and concerns of the community.
- 2. On 26 November 2016 the Methodist Centre, High Littleton was used for the "Big Neighbourhood Drop-in Launch was conducted from 10 am to 4pm. The set-up for the day consisted of: a reception desk to welcome, record, brief attendees on the event and issue questionnaires; wall displays to outline the neighbourhood planning process, parish maps and background information. Additional tables were provided for attendees to complete their questionnaires. Members of the Neighbourhood Plan Steering Group were on hand to answer queries on the planning process and to facilitate completion of the questionnaires. A total of 74 people attended the session with 57 questionnaires completed, additional questionnaires were returned after the even to make a total of 63 returns.
- 3. The questionnaires were collated and consolidated with the original returns archived as a permanent record. The resulting spreadsheet was reviewed to determine similar views expressed by multiple respondents and then these views were aligned to neighbourhood planning objectives to develop emerging themes that reflected the majority views of respondents. The output of this analysis was then reviewed to ensure its accuracy against the community views expressed. The community's vision, planning objectives with associated themes, were outlined as follows:
 - **Vision.** Retain and enhance High Littleton's and Hallatrow's unique heritage and rural setting through sympathetic development that provides an attractive and safe environment for the whole community.
 - Neighbourhood Planning Objectives and Associated Themes:
 - Housing & Development. Support "infill" & "brownfield development" in sympathy
 with the existing character of the Parish to meet the housing needs of the whole
 community.
 - Traffic & Transport. Prioritise measures to improve road safety while reducing traffic congestion through the Parish.
 - Community. Support projects to encourage a "single parish focus" including development of facilities for the whole community.
 - Environment. Protect and promote the green spaces and rural environment of the Parish.
 - Heritage. Maintain and celebrate the unique heritage of parish, historic links to coal mining & geology.
 - Economy. Support businesses that contribute to the community and provide modern infrastructure to encourage local employment.

4. Initial reports on the engagement process were published on the High Littleton Parish Council website and in the High Littleton and Hallatrow News and Views magazine. The Final Report back to the community was delivered to 883 properties in the Parish over the period 9 and 10 February 2017. This report included the community's vision for future development in the Parish, the 6 neighbourhood plan objectives with associated themes, recognised that some issues were outside the scope of the neighbourhood planning process, but needed to be progressed in other ways; invited parishioners to contribute further to the planning process. The Steering Group also identified the next steps in the neighbourhood planning process to: build the evidence base, review options for the Plan, write the draft Plan, and continue consultation with the community.

Report on Community Engagement

Introduction

5. The High Littleton Parish Council decided to raise a Neighbourhood Plan and formed a Neighbourhood Plan Steering Group to develop a plan on behalf of the community to create a vision for the future development and use of land. At the 2011 National Census a total of 850 households had been identified in the Parish covering High Littleton and Hallatrow with some remote farms and residences throughout the Parish. A community engagement process was planned with the first event, a "Big Neighbourhood Drop-in Launch" to be held on 26 Nov 16 at the Methodist Centre, High Littleton. Support, for staging the event, was provided by the Community Team from B&NES Council.

Set up of the "Big Neighbourhood Drop-In Launch"

- 6. **Publicity.** Publicity for the event consisted of:
 - A Flyer to all households in the parish during the period 19 20 November and delivered by a local team paid to make the delivery.
 - A Poster for placing at 20 convenient information points around the Parish displayed during the period 17 26 November

Copies of the publicity are shown at Annex A. In addition, notification of the event was placed on the Parish Council website and in the "High Littleton & Hallatrow News & Views" September & October Edition.

- 7. Community Questionnaire. A questionnaire was devised by the Steering Group to enable residents to give views on:
 - What they would love or wish to preserve in the Parish of High Littleton and Hallatrow?
 - What would they like to improve?
 - What would be their aspirations for High Littleton and Hallatrow?

We sought their views on a wide range of subjects and gave 14 areas that they might wish to comment on as well as allowing them to raise other issues/concerns. The areas we identified were:

- 1. New village homes.
- 2. Highways and car parking.
- 3. Security and policing.
- 4. Public transport.
- 5. Education facilities.
- 6. Local health facilities.

- 7. Internet broadband.
- 8. Local business and innovation/tourism.
- 9. New building development.
- 10. Village amenities.
- 11. Farming and rural.
- 12. Protection of heritage.
- 13. Environment issues.
- 14. Other issues.

It was accepted that the views we were canvassing included issues outside of the scope of the Neighbourhood Plan but this survey would provide a holistic record of the issues and concerns of the community.

Conduct of the Big Neighbourhood Drop-in Launch Event 26 Nov 16

- 8. One large room within the Methodist Centre was used with event signage displayed outside the building. The room was set up with:
 - A reception table to record attendees, give a short brief on the event and to issue and receive questionnaires when completed.
 - A number of wall displays to outline the process for completing a Neighbourhood Plan; background information on the how local communities should be involved in the planning process; and wall maps showing the layout of the Parish.
 - A central table showing further map displays and 4 tables to allow attendees to fill complete the questionnaire.

Members of the Steering Group were present to welcome and brief attendees as they arrived, to guide them through the planning process and to answer general questions on Neighbourhood Planning. In addition, volunteers were available to assist people who might need help in completing the questionnaire.

9. The event started at 10 am and was completed at 4 pm. The breakdown of attendees in the period was as follows:

From the event 57 completed questionnaires with additional questionnaires being returned up to 2 weeks later making a total of 63 returns.

Analysis of Questionnaires

10. Analysis of Questionnaires. Several members of the Steering Group first collated and consolidated the 63 questionnaires in to a spread sheet, which is enclosed with the report. The individual questionnaires have been archived in hard copy. The spread sheet was reviewed to determine whether there were multiple respondents expressing similar views. These views were aligned to the Neighbourhood Planning Objectives and then compared to develop a number of 'themes' that reflected the majority view of respondents. The output of this analysis was then reviewed by members of the Steering Group to ensure the opinions of the parish (including

views expressed at the 'drop in' event) had been accurately represented. A Community Vision was developed from the themes as a short statement to express a long-term view of what members of the parish wish to retain and change through the Neighbourhood Plan.

- 11. The Community's Vision and Associated Themes are listed below and will be tested at future consultation events.
 - The Community's Vision: Retain and enhance High Littleton's and Hallatrow's unique heritage and rural setting through sympathetic development that provides an attractive and safe environment for the whole community.
 - Neighbourhood Planning Objectives and Associated Themes:
 - Housing & Development. Support "infill" & "brownfield development" in sympathy
 with the existing character of the Parish to meet the housing needs of the whole
 community.
 - Traffic & Transport. Prioritise measures to improve road safety while reducing traffic congestion through the Parish.
 - Community. Support projects to encourage a "single parish focus" including development of facilities for the whole community.
 - Environment. Protect and promote the green spaces and rural environment of the Parish.
 - Heritage. Maintain and celebrate the unique heritage of parish, historic links to coal mining & geology.
 - Economy. Support businesses that contribute to the community and provide modern infrastructure to encourage local employment.

These objectives were also allocated associated themes which reflected the community's views on the issues raised at the Neighbourhood Plan Drop-in Launch.

Report Back to Community

Initial Report Back to Community

12. On 28 November 2016 a brief report was submitted to the High Littleton Parish Council Website and "High Littleton and Hallatrow News and Views" January & February 2017 Edition as follows:

'High Littleton Neighbourhood Plan Drop-In Launch held on Saturday 26th November 2016
Some 80 parishioners attended the Neighbourhood Plan drop-in event on Saturday 26th November and provided varied and strong comments on a wide range of issues. Of particular note, was concern over traffic density and speed in the villages and the reduction in local bus services. A number of Hallatrow residents were concerned over the lack of facilities there. Many people appreciated the need for housing development but only if the rural character of the Parish could be preserved. Thank you to all who attended the drop-in event and provided feedback. The NP Steering Group will now start working to process and analyse the many comments provided and will decide what supporting studies are needed before developing the policies and proposals to be included in the NP. Parishioners' views will be sought at a further community engagement event to be held in 2017.

Feedback on views expressed at the NP Drop-in Event on 26th November is being delivered to parishioners. The views of local businesses are also being sought and a Landscape Assessment Survey is to be undertaken to support the NP. Work is underway in drafting the NP for consultation with parishioners later in the year.'

The report was placed on the Parish Council Website; however, as the full report to Parish residents had already been delivered (see below), only the "Feedback paragraph" was printed in the High Littleton & Hallatrow News & Views March & April 2017 Edition.

Final Report Back to Community

- 13. The final report back to the community was completed and approved by the Steering Group for delivery to all households in the Parish. The document:
 - Included the "Community's Vision" and the 6 Neighbourhood Plan Objectives with Associated Themes.
 - Also recognised that some of the issues expressed by the community were outside of the legal scope of the Neighbourhood Plan. The Steering Group would review the way forward to resolve these issues outside of the Neighbourhood Plan with the Parish Council and additional community action groups might be required to progress these issues.
 - Also invited parishioners to contribute further by contacting the Neighbourhood Planning Steering Group.
- 14. Next Steps in Planning Process. The Neighbourhood Plan Steering Group identified the next steps to be taken in the planning process:

Build the Evidence Base:

- Carry out a survey with local businesses
- Continue to review past reports and surveys to gather evidence.
- Identify gaps in that evidence.
- Compile new evidence.
- Analyse evidence gathered.

Review Options for the Plan

- Prioritise issues and themes.
- Look at Options.

Write Draft Plan

- Consider policies, proposals & site allocations.
- Consider sustainability, diversity, equality & delivery.

Consult

- Keep residents, community and businesses informed of progress (mail drops, Parish "News & Views", Facebook and Parish Council Website).
- Produce draft Neighbourhood Plan for consultation.

The Final Report Back to the Community is shown at Annex B.

15. Delivery of Final Report Back to Community. The Final Report (in A4 size tri-fold leaflets) was delivered to all households in the Parish in the period 9 & 10 February 2017. The High Littleton and Mearns area was sub-divided in to 7 delivery rounds with 697 properties. The Hallatrow and Whitecross area was sub-divided in to 4 delivery rounds with 186 properties. The total delivered was to 883 properties, 33 properties more than provided in the 2011 National Census. The Parish delivery areas are shown at Annex C and will be used for organising further leaflet drops to the community.

Executive Summary

- 1. Community engagement is a critical part of producing a Neighbourhood Plan. As well as being an integral part of the process for producing a plan, the plan is only of value if it reflects the views and priorities of the community it represents. Engagement is also fundamental to the plan gaining the support it requires to pass a referendum and to become part of planning legislation.
- 2. On 26 November 2016, the first community engagement event for the High Littleton and Hallatrow Neighbourhood Plan was held at the Methodist Church, High Littleton and consisted of a number of presentations and displays facilitated by the Neighbourhood Plan Steering Group. This event identified the planning priorities for residents and wider issues that were impacting on our parish. Feedback from this event was used to develop the first draft Neighbourhood Plan for High Littleton and Hallatrow and a vision for our parish.
- 3. A second community engagement event was held on 28th January 2023 at the Church Hall, High Littleton following a similar format to the 2016 event. The long period of time between the two events was due, first, to changing higher level planning policies (the West of England Combined Authority's Joint Spatial Plan and B&NES's Local Plan were still being developed) and, second, COVID preventing social gatherings. The second event could present a draft Neighbourhood Plan containing objectives and policies that built on the information from the first event. The event also allowed residents to comment on wider issues, outside the remit of the plan, that could be used to set priorities for the community and inform an action plan for the Parish Council to progress.
- 4. Feedback from residents who attended the second engagement demonstrated overwhelming support for the policies of the draft Neighbourhood Plan. Additionally, the event highlighted the community's priorities for issues not covered by the Neighbourhood Plan, including:
 - The lack of public transport to our community
 - Growing concerns about speeding traffic and congestion on the A39
 - A desire to develop a better sense of community and to bring together existing community groups to work together
 - Frustration that the Church Farm building in in High Littleton remains an eyesore
 - A need to improve access to footpaths and green spaces
- 5. The draft Neighbourhood Plan will be amended to incorporate feedback from the event ready for the next step in the process, formal consultation.
- 6. A report summarising the key points from the Drop In and how residents' feedback will be taken forward has been produced and will be shared with the Parish Council and the community.

Report on the Second Community Engagement Event

Introduction

11. The second community engagement event was organised for 28th January 2023 from 11am to 3pm at the Church Hall, High Littleton. The date, time and location were chosen to maximise the attendance by residents of High Littleton and Hallatrow. A summary of the event is provided below.

Set up of the "Community Drop-In"

12. Publicity

Publicity for the event consisted of:

- Awareness of the Neighbourhood Plan and community drop-in was raised in November and December through the Parish Council's Chairman's editorial in the parish newsletter, a news item in the High Littleton School newsletter and through the Parish Council Facebook page.
- A Flyer delivered with the parish Newsletter to all households in the parish approximately 3 weeks before the event.
- Reminders were sent through social media in the week before the event was held.

Copies of the publicity are shown at Annex A.

13. Community Feedback.

A questionnaire was devised by the Steering Group to enable residents to indicate if they supported the policies and objectives of the plan, with additional space to provide comments and feedback. Wall displays were provided at the 'drop-in' to allow residents to engage and offer their views on:

- 1. The key themes of the Neighbourhood Plan policies
- 2. What they value in our community and what they would like changed by adding post-it notes to large maps of High Littleton and Hallatrow
- 3. Any other topics they would like the Parish Council to prioritise.

Conduct of the Community Drop-in event

14. The Church Hall was set up with:

- A reception table to record attendees, give a short brief on the event and to issue and receive questionnaires when completed.
- A number of wall displays to outline the process for completing a Neighbourhood Plan; background information on the how local communities should be involved in the planning process; the policies and objectives of the plan and wall maps showing the layout of the Parish.
- Further displays showed key features of the parish, including views of the landscape and of listed buildings.

- Tables and chairs were provided to allow attendees to complete the questionnaire and teas/coffees and cakes were provided free of charge to encourage people to attend and to sit and chat with each other.
- 15. Members of the Steering Group were present to welcome and brief attendees as they arrived, to guide them through the planning process and to answer general questions on Neighbourhood Planning. In addition, volunteers were available to assist people who might need help in completing the questionnaire.
- 16. The event started at 11 am and was completed at 3 pm. 54 adults attended along with approximately 20 children. 47 questionnaires were completed by adult residents of the parish.

Analysis of Questionnaires and Community Feedback

- 17. Questionnaires were consolidated into a single spreadsheet and anonymised. The results showed overwhelming support for the policies of the draft plan and allowed comments and feedback to be reviewed to develop themes. The results from the questionnaires are summarised at Annex B.
- 18. The key themes derived from comments made by residents are summarised as:
 - A lack of public transport to our community prevents younger and older residents from accessing key services and employment opportunities in surrounding cities. In time, this will lead to a growing poverty gap between city and rural communities. It also runs counter to the Local Authorities declared objective to achieve Net Zero.
 - Traffic issues continue to dominate residents' concerns. At different times of the day, the A39 suffers from severe congestion and speeding traffic. With a school and other community assets positioned along the A39, the narrow pavements put pedestrians at risk.
 - There is a clear desire from residents to develop a better sense of community. A lack of
 an obvious parish centre and community hall does not help, but there are other ways to
 address the concerns, such as by providing village notice boards and by bringing
 together existing community groups to work together.
 - There is considerable frustration that the Church Farm building in High Littleton remains an eyesore (after around 15 years of being supported by scaffolding). Its location at the historic core of the village is an embarrassment to residents.
 - Residents asked that signage and access to footpaths and green spaces could be improved.
 - There was clear support for sustainable building methods, such as better use of grey water and improved drainage (to reduce the impact on biodiversity).
