ALLOCATIONS STATEMENT FOR MOORLANDS INFANT SCHOOL

PLACES AVAILABLE: 60

As Moorland Infant School was oversubscribed it was necessary to use the Academy Trust's admissions criteria, as published in 'A Primary School for Your Child' – 2024/25', to allocate the places available at the school. Applications for all schools are considered under an equal preference system which means that all preferences (1st, 2nd & 3rd) for each school are considered equally. If there are any cases where more than one of the school preferences named on the application form could have been met only the highest preference school has been allocated.

A total of **148** preferences were originally received for Moorlands Infant School which has an Admission Number of **60**.

How the initial allocation of places was made for this school:

0 places have been held for children with an Education, Health and Care Plan where the school is being consulted for their plan.

0 Category A Applicant - Looked after child or previously looked after child.

37 Category B Applicants - Children who live within a 1.5 mile radius of the school and for whom there will be a sibling in attendance in either Moorlands Infant or Junior School on the admission date at the school.

0 Category C Applicants - Children who live outside a 1.5 mile radius of the school but it is their closest school and for whom there will be a sibling in attendance in either Moorlands Infant or Junior School on the admission date at the preferred school.

23 Category D Applicants - Children who live closest to the school as measured in a direct line from the address point of the school. The furthest direct line distance between the preferred school and the home address offered in this category was **0.690** miles.

17 children have initially been refused a place at Moorlands Infant School. (All other preferences originally considered have qualified for another school as a higher preference)

CLASS SIZE PREJUDICE APPEALS – Effects of Infant Class Size Legislation:

Appeals for Moorland Infant School will be heard on the basis of Infant Class Size Prejudice as the school will organise with two Reception classes each containing 30 pupils with one full-time qualified teacher (or the equivalent of) in each class.

Statement Date 16 April 2024

Position as at 29 May 2024 following initial allocations on 16 April 2024

Following the initial allocations on 16 April 2024, 1 further place has become available.

9 parents originally refused a place opted to appeal, 3 opted to go on the waiting list and 1 late application was received.

These children were considered for the 1 place available, and it has been offered to a child under Category D Applicants - Children who live closest to the school as measured in a direct line from the address point of the school. The furthest direct line distance between the preferred school and the home address offered in this category was **0.145** miles

Statement Date 29 May 2024

Position as at 13 June 2024 following initial allocations on 16 April 2024

1 further place has become available.

4 parents originally refused a place are appealing, 4 have opted to go on the waiting list and 1 further late application has been received.

All the children were considered for the 1 place available, and it has been offered to a child under Category D Applicants - Children who live closest to the school as measured in a direct line from the address point of the school. The furthest direct line distance between the preferred school and the home address offered in this category was **0.951** miles.

Statement Date 13 June 2024

Position as at 1 July 2024 following Appeals

3 appeals were heard by an independent appeal panel. All appeals were dismissed.

1 further place has become available.

This has been offered to a child under Category B Applicants - Children who live within a 1.5 mile radius of the school and for whom there will be a sibling in attendance in either Moorlands Infant or Junior School on the admission date at the school. The furthest direct line distance between the preferred school and the home address offered in this category was **0.505** miles
