Thank you for consulting National Highways on the revised Consultation Statement and the complete Landscape Character Assessment (LCA) for the High Littleton and Hallatrow Neighbourhood Development Plan.

National Highways is responsible for operating, maintaining and improving the strategic road network (SRN) which in this instance consists of the A36, located approximately 13.4km east and the A46 which runs approximately 18.5km north-east of the plan area.

We have reviewed the revised documents and are satisfied that they are unlikely to lead to development that will have a significant impact on the SRN.

Bath & North East Somerset Council is currently consulting on the revised Consultation Statement and the complete Landscape Character Assessment (LCA) for the High Littleton and Hallatrow Neighbourhood Development Plan, which has been formally submitted by High Littleton and Hallatrow Parish Council.

Following an initial review by the independent examiner, it was identified that the submitted Consultation Statement did not fully meet the requirements of the Neighbourhood Planning
