BATH AND NORTH EAST SOMERSET COUNCIL

(VARIOUS ROADS, BATH AND NORTH EAST SOMERSET) (PROHIBITION OF STOPPING, WAITING, LOADING AND PARKING PLACES) (CONSOLIDATION) ORDER 2024

The Bath and North East Somerset Council ("the Council") in exercise of its powers under sections 1, 2, 4, 32, 35, 45, 46, 49, 51, 53 and 63A of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the 1984 Act") and of all other enabling powers, after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the 1984 Act, makes the following Order:-

1. This Order comes into operation on the 3rd June 2024 and may be cited as the Bath and North East Somerset Council (Various Roads, Bath and North East Somerset) (Prohibition of Stopping, Waiting, Loading and Parking Places) (Consolidation) Order 2024.

2. In this Order:-

"Bus lane" means an area of road which may be used only by buses (or a particular description of bus), public service vehicles, and some other class or classes of vehicular traffic as specified in this Order;

"Civil Enforcement Officer" has the meaning given by Section 76 of the Traffic Management Act 2004;

"coach" means a vehicle other than a public service vehicle constructed or adapted to carry 12 or more passengers;

"delivering" and "collecting" in relation to goods includes checking those goods for the purpose of their delivery or collection;

"disabled person's badge" has the same meaning as in Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England) Regulations 2000 ("the 2000 Regulations");

"Doctor" means a legally qualified medical practitioner as defined in Section 52 of the Medical Act 1956;

"driver" in relation to a vehicle waiting in a parking place or on a road or length of road, means the person driving or in charge of the vehicle at the time it was left in that parking place or road or length of road;

"emergency vehicle" has the same meaning as in regulation 3(2) of the Road Vehicle Lighting Regulations 1989;

"goods" means any article not easily carried by hand and includes postal packets;

"goods vehicle" means a motor vehicle which is constructed or adapted for use for the carriage of goods or burden of any description, or a trailer so adapted;

"motorcycle" has the same meaning as in Section 136 of the 1984 Act;

"operative time" means a period of time during which a restriction so designated by this Order is in force;

"parking", "parked", or "to be parked" means leaving a vehicle or permitting it to remain at rest, whether the vehicle is attended or unattended and includes "waiting" and "to wait";

"parking authorisation" or a "parking permit" means an authorisation issued by the Council authorising the parking of a vehicle, which may be for a specific vehicle, a specific parking zone and/or a specific parking place. Eligibility for different types of parking authorisation

or permit is set by the Council. A parking authorisation or permit is issued, subject to the Council's discretion, if the applicant is eligible and agrees to the conditions in the application form;

"parking disc" has the same meaning as in the 2000 Regulations;

"parking place" or "parking bay" means any part of a road authorised or designated by this Order and shown on the road by authorised markings, surfacing or paving, and or traffic sign(s) in which a vehicle may be parked according to the conditions set out in the Order;

"parking zone" as highlighted on the maps indicates the extent of the residential properties within the parking zone. It does not represent eligibility for a parking authorisation or parking permit;

"pedal cycle" means a unicycle, bicycle, tricycle, or cycle having four or mor wheels, not being in any case mechanically propelled unless it is an electrically assisted pedal cycle of such class as is to be treated as not being a motor vehicle for the purposes of the 1984 Act; "plans", "maps", and "tiles" means the maps in Schedule 8 to this Order;

"postal packets" has the same meaning as in the Postal Services Act 2011;

"public service vehicle" has the meaning defined in Section 1 of the Public Passenger Vehicles Act 1981;

"relevant date" means the date on which any event occurs or occurred in breach of any of the provisions of this Order or to which this Order relates;

"relevant position" means

- (1) in relation to the display on a vehicle of a permit: -
 - (a) where the vehicle is fitted with a front windscreen, on or immediately behind the front windscreen, with the details clearly visible from outside the vehicle; or
 - (b) where the vehicle is not fitted with a front windscreen, in a conspicuous position on the vehicle, with the details clearly visible from outside the vehicle;

and

(2) in relation to the display on a vehicle of a disabled person's badge in accordance with Regulation 4 of the 2000 Regulations.

"security vehicle" means a vehicle being used for the carriage of money to or from a bank, building society, or business premise;

"school keep clear" means any area of carriageway of a specified road intended to be kept clear of stationary vehicles being in close proximity to a school pedestrian access;

"taxi" has the same meaning given in Schedule 1 of the Traffic Signs Regulations and General Directions 2016;

"telecommunications apparatus" has the same meaning as in Schedule 2 of the Telecommunications Act 1984; and

"traffic sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the Act of 1984.

3. (1) The coloured areas of road shown on the maps represent the lengths of road which are affected by this Order.

- (2) Days and times in the format 'Mon-Sat 8am-6pm' shown on the maps refer to the operative times of that particular restriction. Unless stated otherwise, there is no restriction outside of the operative times shown on the maps.
- (3) Times in the format '30 mins max' or '1 hr max' shown on the maps refer to the maximum length of stay for that particular restriction.
- (4) No Return (NR) shown on the maps refers to the length of time which must elapse once a vehicle leaves a parking place or parking bay, before a vehicle can be reparked in a parking place or parking bay in the same road.
- (5) A permit authorisation or parking permit is only valid in the zone(s) and/or a specific parking place or parking bay or for the specific vehicle to which that permit authorisation or parking permit applies.
- 4. The provisions of this Order do not apply to:-
 - (a) an emergency, fire, ambulance, or police vehicle, provided that the vehicle is clearly distinguishable as such;
 - (b) a vehicle when it is being directed by a police constable in uniform or a Civil Enforcement Officer; or
 - (c) a vehicle in the service of the local authority or its agent which is being used in pursuance of statutory powers or duties, or to maintain the highway;
- 5. Unless stated otherwise, the provisions of this Order do not apply to a vehicle that is parked for as long as is necessary:-
 - (a) to enable a person to get in or out of the vehicle;
 - (b) any vehicle whilst being used to install telecommunications apparatus or in pursuance of statutory powers or duties;
 - (c) to enable the vehicle, if it cannot conveniently be used for such purposes in another road, to be used in connection with:
 - (i) scaffolding or demolition operations;
 - (ii) removing an obstruction or emptying gullies; or
 - (iii) maintaining, improving, or reconstructing any road.
 - (d) for the vehicle to stop if required to do so by law, to avoid an accident, or if it is unavoidable for any other reason;
 - (e) to be used at or near premises adjacent to the road in connection with;
 - (i) a wedding or funeral; or
 - (ii) the cleaning of windows whilst using equipment attached to and working from the vehicle; or
 - (f) to deliver or collect, load or unload the following from premises adjacent to the road, if the premises do not include an adequate off-street loading area and if those activities cannot conveniently be done in another road;
 - (i) goods; or
 - (ii) cash or other valuables or valuable securities which cannot reasonably be carried by hand.

PROHIBITION AND RESTRICTION OF PARKING

Prohibition and Restriction of Parking

- 6. Subject to Article 7, a vehicle must not be parked;
 - (1) in any length of road shown on the maps as No Waiting at Any Time; or
 - (2) between the operative times stated on the label on the maps in any length of road shown on the maps as No Waiting.
- 7. Article 6 does not apply to a vehicle lawfully displaying in the relevant position a valid disabled person's badge, which is exempt for a period of three hours, subject to the conditions that:
 - (a) the period of exempted parking does not begin less than one hour after a previous period of exempted parking by the same vehicle in the same road on the same day; and
 - (b) a parking disc is displayed in the relevant position on the vehicle marked to show the quarter hour period during which the period of exempted parking began.

This exemption does not apply if there is a No Loading restriction, as stated in article 9, in operation.

No Stopping on Entrance Markings

- 8. (1) A vehicle must not stop on the entrance markings shown on the label on the maps as School Keep Clear No stopping at any time on entrance markings.
 - (2) A vehicle must not stop during the operative times on the entrance markings shown on the label as School Keep Clear No stopping on entrance markings, if operative times are stated on the label on the maps.
 - (3) Article 5(a), (b), (c), (e) and (f) does not apply to paragraphs (1) and (2).

Prohibition of Parking/Loading/Unloading

- 9. (1) A vehicle must not be parked, loaded or unloaded in any length of road shown on the maps as No Waiting and No Loading at Any Time.
 - (2) A vehicle must not be parked during the operative times stated on the label on the maps or loaded or unloaded during the operative times stated on the label on the maps in any length of road shown on the maps as No Waiting & No Loading.
 - (3) Article 5(b), (c), (e) and (f) does not apply to paragraphs (1) and (2).

AUTHORISATION AND DESIGNATION OF PARKING PLACES

- 10. (1) A vehicle must not be parked in a free parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.
 - (2) A vehicle must not be parked in a disabled badge holder parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.

- (3) A vehicle must not be parked in a loading bay shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.
- (4) A vehicle must not be parked in a motorcycle parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.
- (5) A vehicle must not be parked in a coach parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.
- (6) A vehicle must not be parked in a permit holder parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.
- (7) A vehicle must not be parked in a car club permit holder parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.
- (8) A vehicle must not be parked in a doctor permit holder parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.
- (9) A vehicle must not be parked in a paid for parking place shown on the maps during the operative times stated on the labels on the maps unless it is permitted to do so in accordance with this Order.

Free Parking Place

- 11. (1) Each length of road shown on the maps as Free Parking is authorised for use as a parking place during the operative times stated on the label on the maps.
 - (2) A vehicle must not be parked in such a parking place for longer than the maximum period of parking (Max) as stated on the label on the maps.
 - (3) A vehicle must not be re-parked in a parking place in the same road within the No Return (NR) time as stated on the label on the maps.

Disabled Badge Holders Parking Places

- 12. (1) Each length of road shown on the maps as Disabled Badge Holders Only is authorised for use as a parking place for disabled badge holders only. A vehicle must not be parked in such a Disabled Badge Holders parking place unless the vehicle lawfully displays a disabled person's badge in the relevant position.
 - (2) Each length of road shown on the maps as Disabled Badge Holders Only between the operative times stated on the label on the maps is authorised for use as a parking place for disabled badge holders during the operative times stated on the label on the maps. A vehicle must not be parked in such a parking place;
 - (a) unless the vehicle lawfully displays a disabled person's badge in the relevant position;
 - (b) where so indicated on the maps for a period longer than that stated on the maps; and
 - (c) where so indicated on the maps must not be re-parked in a parking place in the same road within the time period stated on the maps after leaving it.
 - (3) Article 5 (a), (b), (c), (e) and (f) does not apply to paragraphs (1) and (2).

Loading Bays

- 13. (1) Each length of road shown on the maps as Loading Only is authorised for use as a loading bay. A vehicle must not be parked in such a loading bay, unless the vehicle is being loaded or unloaded, or goods are being delivered to or collected from the vehicle.
 - (2) Each length of road shown on the maps as Loading Only between the operative times stated on the label on the maps is authorised for use as a loading bay during the operative times stated on the label on the maps. A vehicle must not be parked in such a loading bay during the operative times:
 - (a) unless the vehicle is being loaded or unloaded, or goods are being delivered to or collected from the vehicle;
 - (b) where so indicated on the maps, for a period longer than that stated on the maps; and
 - (c) where so indicated on the maps, must not be re-parked in a loading bay in the same road within the time period stated on the maps after leaving it.
 - (3) Each length of road shown on the maps as Goods Vehicles Loading Only is authorised for use as a loading bay. A vehicle must not be parked in such a loading bay, unless the vehicle is a good vehicle and is being loaded or unloaded, or goods are being delivered to or collected from the vehicle.
 - (4) Each length of road shown on the maps as Goods Vehicle Loading Only between the operative times stated on the label on the maps is authorised for use as a loading bay during the operative times stated on the label on the maps. A vehicle must not be parked in such a loading bay during the operative times, unless the vehicle is a goods vehicle and being loaded or unloaded, or goods are being delivered to or collected from the vehicle.
 - (a) unless the vehicle is a goods vehicle being loaded or unloaded, or goods are being delivered to or collected from the vehicle;
 - (b) where so indicated on the maps, for a period longer than that stated on the maps; and
 - (c) where so indicated on the maps, must not be re-parked in a loading bay in the same road within the time period stated on the maps after leaving it.

Solo Motorcycle Parking Places

14. Each length of road shown on the maps as Solo Motorcycles Only is authorised for use as a parking place for motorcycles only. A vehicle must not be parked in such a parking place unless the vehicle is a motorcycle.

Coach Parking Places

- 15. (1) Each length of road shown on the maps as Coach Parking is authorised for use as a parking place for coaches only. A vehicle must not be parked in such a parking place unless the vehicle is a coach.
 - (2) Each length of road shown on the maps as Coach Parking between the operative times stated on the label on the maps is authorised for use as parking place for coaches only during the operative times stated on the label on the maps. A vehicle must not be parked in such a loading bay during the operative times, unless the vehicle is a coach.

- (3) Each length of road shown on the maps as Coach Parking between the operative times stated on the label on the maps is authorised for use as a parking place for coaches during the operative times stated on the label on the maps. A vehicle must not be parked in such a parking place;
 - (a) unless the vehicle is a coach;
 - (b) where so indicated on the maps for a period longer than that stated on the maps; and
 - (c) where so indicated on the maps must not be re-parked in a coach parking place in the same road within the time period stated on the plans after leaving it.

Permit Parking Places

- 16. (1) Each length of road shown on the maps as a Permit Parking Place is designated between the operative times stated on the label on the maps as a permit parking place.
 - (2) A vehicle must not be parked in such a parking place during the operative times unless:
 - (a) the vehicle displays a valid permit in the relevant position; or
 - (b) the vehicle has been issued with a valid parking authorisation.

Car Club Permit Holders Only

- 17. (1) Each length of road shown on the maps as a Car Club Permit Holders Only is designated as a parking place for car club vehicles only.
 - (2) A vehicle must not be parked in such a parking place unless:
 - (a) the vehicle displays a valid car club permit in the relevant position; or
 - (b) the vehicle has been issued with a valid car club parking authorisation.

Doctor Permit Holders Only

- 18. (1) Each length of road shown on the maps as a Doctor Permit Holders Only is designated as a parking place for doctor permit holders only.
 - (2) A vehicle must not be parked in such a parking place unless:
 - (a) the vehicle displays a valid doctors permit in the relevant position; or
 - (b) the vehicle has been issued with a valid doctors parking authorisation.

Paid for Parking Places

- 19. (1) Each length of road shown on the maps as Paid For Parking is designated between the operational times stated on the label on the maps as a paid-for parking place.
 - (2) A vehicle must not be parked in such a parking place during the operative times unless a parking charge as specified in columns 2 to 9 of Schedule 1 is paid for the specific location identified in column 1 for the appropriate period of parking. The parking charge is payable according to the terms and conditions shown at the appropriate parking charge machine.
 - (3) If a parking ticket is issued the valid parking ticket must be clearly displayed in the relevant position.
 - (4) If a parking ticket is not issued a valid parking authorisation must be held.
 - (5) A vehicle must not be parked in such a parking place for longer than the maximum period of parking (max) stated on the label on the maps for that particular parking place.

- (6) A vehicle must not be re-parked in a parking place in the same road within the No Return (NR) time as stated on the label on the maps for that parking place.
- (7) Paragraphs (2), (4) (5) and (6) do not apply to a vehicle displaying a valid disabled persons badge in the relevant position.
- (8) Paragraphs (2) and (4) do not apply to a motorcycle.
- (9) A parking ticket or authorisation is only valid in the parking place where or for which it is issued.

Permit Parking & Free Parking Places

- 20. (1) Each length of road shown on the maps as Permit Parking & Free Parking place is designated between the operative times stated on the label on the maps as a parking place for permit parking or free parking.
 - (2) A vehicle must not be parked in such a parking place unless Article 11 or Article 16 applies.

Permit Parking & Paid for Parking Places

- 21. (1) Each length of road shown on the maps as Permit Parking & Paid for Parking Place is designated between the operative times stated on the label on the maps as a parking place for permit parking or paid for parking.
 - (2) A vehicle must not be parked in such a parking place unless Article 16 or Article 19 applies.

Conditions of Use of all Parking Places

- 22. (1) The limits of each parking place or loading bay will be marked on the road by authorised carriageway markings and/or signs.
 - (2) Every part of the vehicle must be parked within the markings of the parking place.

Suspension of Use of Parking Places

- 23. (1) A police constable in uniform or any person authorised by the Council may suspend the use of a parking place whenever such suspension is necessary.
 - (2) A vehicle must not be parked in a suspended parking place, unless:
 - (a) authorised to do so by the Council; or
 - (b) the vehicle is being used for fire brigade, ambulance, or police purposes.
 - (3) A builders skip or receptacle, building materials or scaffolding must not be left in, or overhang a suspended parking place, unless authorised to do so by the Council.
 - (4) A traffic sign indicating that parking is suspended will be placed in, or adjacent to, the parking place when any suspension is in force.


