

# SECTION 14 OF THE ROAD TRAFFIC REGULATION ACT 1984

### BATH AND NORTH EAST SOMERSET COUNCIL (PUBLIC FOOTPATH AQ75, FOX HILL, COMBE DOWN, BATH) (NO. 2) TEMPORARY TRAFFIC REGULATION ORDER 2024

Bath and North East Somerset Council ("the Council") being the highway authority for Public Footpath AQ75, Fox Hill, Combe Down, Bath in the County and District of Bath and North East Somerset is satisfied that pedestrian traffic in the said public footpath should be restricted because works are being or are proposed to be executed on or near the road to facilitate construction of a new storm storage tank works by Wessex Water.

The Council in exercise of its powers under section 14 of the Road Traffic Regulation Act 1984 and of all other enabling powers hereby makes the following order:

1. No person shall proceed in the section of Public Footpath AQ75, Combe Down, Bath commencing from its junction with Fox Hill at grid reference ST 7514 6306 (point A on the Order Map) and proceeding in a generally east southeasterly direction for approximately 206 metres to grid reference ST 7532 6297 (point B on the Order Map).
2. Nothing in Article 1 of this order shall apply to any contractor necessarily proceeding to or from the said works.
3. Nothing in Article 1 of this order shall apply to any pedestrian requiring access to any premises situated on or adjacent to the public footpath, or to any other premises accessible for pedestrians from, and only from, the public footpath.
4. This order shall come into operation on 19<sup>th</sup> July 2024 and will be operative until 7<sup>th</sup> October 2024. The closure will only be effective during that period when signs stating 'Footpath Closed' are in place on site.
5. The Order may be cited as the Bath and North East Somerset Council (Public Footpath AQ75, Fox Hill, Combe Down, Bath) (No. 2) Temporary Traffic Regulation Order 2024.
